Services include cleaning general office areas, lobbies, bathrooms, common areas, and all other services specified in the specification. The IFB required the winning vendor to have three (3) successful years of previous experience providing similar services at one or more properties of comparable size, registered with the MS Secretary of State, and insurance coverages.
