LEADERSHIP MESSAGE

On February 1st, 2017, Governor Bryant gave me the privilege to lead Mississippi's top law enforcement agency. It is my distinct honor to follow in the footsteps of other distinguished professionals in this position. While I have been at the helm of this agency for a relatively short time during this fiscal year, I believe we have continued this agency's pursuit of protecting and serving our citizens.

Our shared mission at the Mississippi Department of Public Safety (MDPS) is to make Mississippi a safe and secure state by patrolling its roads and highways, keeping drugs off our streets, investigating criminal activities and providing training and support to law enforcement agencies across Mississippi. During this past fiscal year, MDPS has not only maintained these basic law enforcement functions charged to us, but has stretched itself to move beyond the basics. We have undertaken the arduous task of law enforcement accreditation to demonstrate our commitment to professionalism. In FY2017, the Mississippi Legislature appropriated funding for Class 62 of the Mississippi Highway Safety Patrol. It is the agency's goal to continue to address the chronic shortfall in sworn officers experienced in recent years.

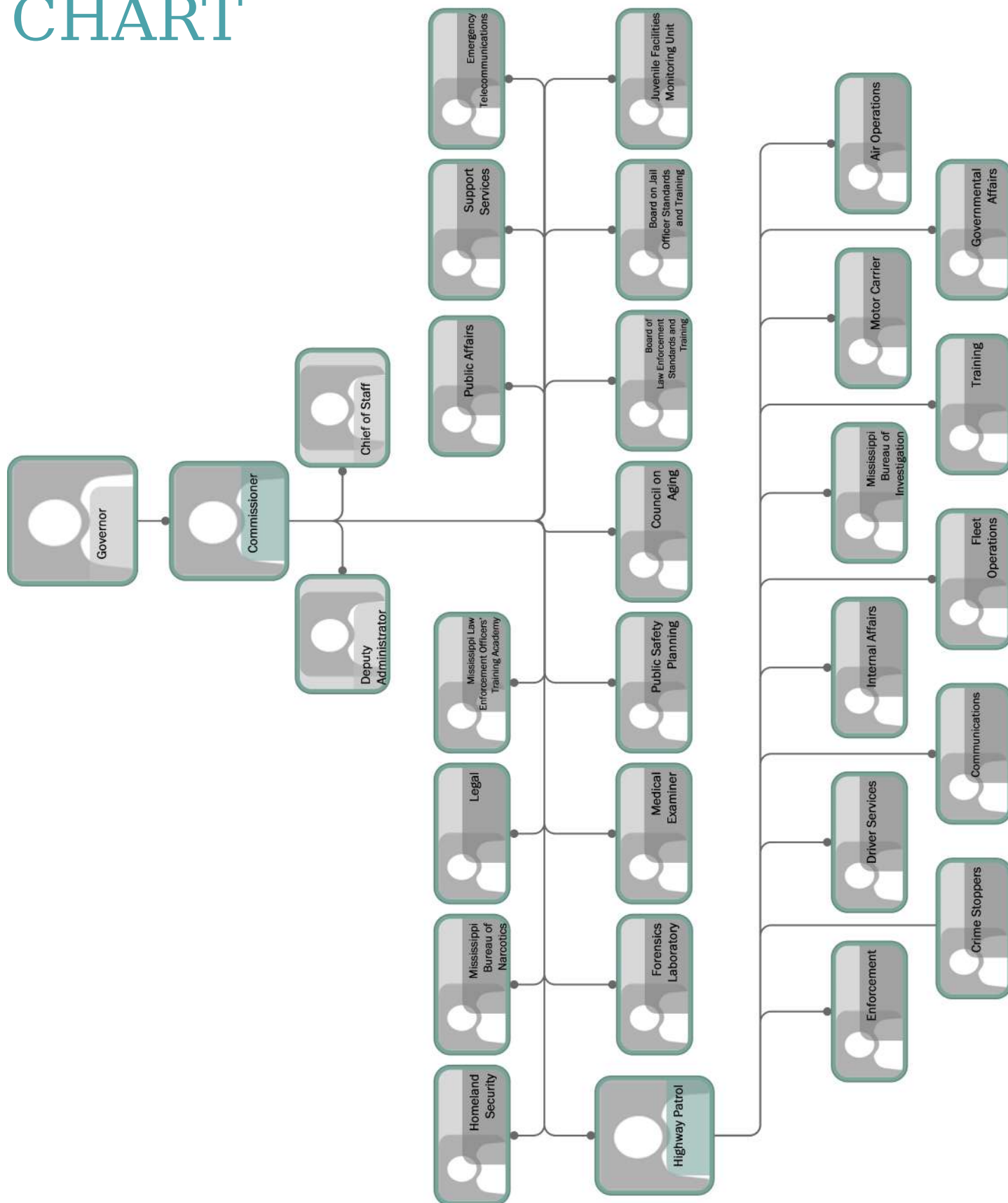
Within our state, drug abuse continues to be a matter of serious concern. My 40 years of service in law enforcement with a concentration in narcotics has given me a unique perspective about this area. Much of the crime we see committed in this state has roots in drug trafficking and gang activity. Thus, we have joined in renewed efforts to combat



illegal drug trafficking and stem the tide of opioid abuse – a national crisis. While a multi-disciplinary approach is necessary for solving these complex issues, law enforcement serves a critical role in these efforts and we will continue to be a standard-bearer.

I am pleased to present the Department of Public Safety's Annual Report for Fiscal Year 2017 as required by statute. This report provides an overview of the accomplishments of the agency's thirteen divisions in FY2017. We made noteworthy progress in both continued and emerging endeavors – succeeding in overcoming the significant challenges of serving and protecting the citizens of Mississippi while maintaining proper fiscal restraint.

MISSISSIPPI HIGHWAY SAFETY PATROL



The mission of the Mississippi Highway Safety Patrol (MHSP) is to be a service-oriented organization dedicated to providing for the safety of the public on Mississippi highways and to keep Mississippi citizens free from the fear of lawlessness. To this end, MHSP promotes the safe operation of motor vehicles on the state's roads and highways by professionally and competently enforcing the rules of the road as set forth in Title 63 of the Mississippi Code of 1972.

Furthermore, upon request, MHSP assists counties and municipalities with limited resources and expertise in resolving crimes and other law enforcement-related issues in their jurisdictions. Additionally, MHSP effectively and efficiently serves Mississippians by providing and maintaining records of more than 2.7 million state-issued documents such as driver licenses, identification cards and firearm permits. Finally, MHSP responds to any natural or man-made disaster upon orders from the governor to keep Mississippi citizens as safe as possible under these arduous circumstances.

The two primary components of MHSP are the Enforcement and Driver Services divisions. Even though each division's areas of responsibility are diverse and multifaceted, both work closely together to achieve the agency's overall objective - to protect life and property by maintaining law and order with courtesy, superior service, and professionalism.

ENFORCEMENT

MHSP consists of nine (9) regional Troops across the state that are charged with providing day-to-day law enforcement and support of local agencies in the interest of public safety. Troopers assigned to district offices are the first line of response to public need in the state. These troopers patrol all highways in their districts and comprise a visible force to serve as an assurance of protection and a deterrent for those who would seek to cause harm or chaos. These Troopers also enforce state and federal traffic laws on highways, make arrests, and assist motorists in time of need.

Troopers are also assigned to full-time duties within the Motor Carrier Division. There they are charged with the primary responsibility of enforcement of the Federal Motor Carrier Safety Act and ensuring the compliance of commercial vehicles with these laws. Enforcement also serves as a support to city and county departments as well as state and federal partners at their request in time of need or crisis. Additionally, Troopers are assigned to the Interdiction and K9 Unit. Troopers on this unit work to identify and apprehend career criminals traveling on Mississippi highways in commission of their crimes. They also provide support across the state with K9 units trained in narcotic and explosive detection.





The Mississippi Bureau of Investigation (MBI) is charged with investigating, reporting and preventing criminal activities within the state and coordinating activities between federal, state, and local authorities involved in crime prevention and criminal investigations. Within MBI are a number of units providing specific functions for the state.

The Protective Services Division provides executive security for the Governor and Lieutenant Governor, their families, and visiting dignitaries. The Special Operations and Major Crimes Unit coordinates MBI's covert operations; provides technical assistance and surveillance to MBI and local law enforcement agencies; and also aides in fugitive apprehension, anti-terrorism and special investigations. The Crime Scene Unit is made up of Forensic Scientists who specialize in crime scene analysis who travel throughout the state to process scenes, prepare forensic reports for District Attorney Offices, give depositions when requested, testify as experts in the field of crime scene analysis, and instruct law enforcement in crime scene preservation. The Criminal Information Center (CIC) is responsible for the communication of vital information relating to crimes, criminals, and criminal activity. It is the state's criminal records repository, and provides fingerprint-based identification services to law enforcement and other criminal justice entities in the State of Mississippi and throughout the United States. MBI also has three regional Victim Coordinators whose primary focus is to provide educational materials and information to victims regarding their rights.

The Salvage Division is responsible for monitoring and regulating motor vehicle parts and repair, performing Vehicle Identification Number (VIN) verifications and salvage-titled vehicle examinations.

The CRASH Team consists of highly trained troopers whose responsibility is to provide expert investigation, analysis, and reconstruction of Motor Vehicle Accidents (MVAs) where the likelihood of criminal prosecution is great. These Troopers have received enhanced training, which allows them to serve as experts in the field. The CRASH Team also provides quality control and accuracy of all MVAs investigated by the agency as well as meet training needs of the agency throughout the year. Members of this unit also serve as instructors for MHP Cadets and basic law enforcement classes at MLEOTA. Other divisions include Public Affairs and Training. The divisions of the MHSP are supported by civilian personnel with expertise in many fields not limited to communications, fleet services, IT, maintenance, internal security and supply.

The Air Operations Unit provides aerial support with two (2) aircraft owned by the agency. Examples of their duties include tactical support for SWAT and SOG, search and rescue missions, eradication missions, personnel movements, and surveillance details.

MHSP also maintains the capabilities to deploy SWAT, SOG, Motorcycle, and Honor Guard units. Each of these units is made up of Troopers across the state whose primary responsibilities are enforcement duties and, in most cases, have volunteered for these extra duty roles. The SWAT Team is called to respond based the request of agencies across the state when specialized tactical support is needed.

The SOG unit is available at the request of other agencies to provide assistance in potential civil unrest, crowd control, manhunts, tracking, lost or missing persons and security for MDOC or other agency making request jail searches. The Motorcycle unit provides escorts for dignitary and funeral details, additional enforcement assistance in areas of high accident rates and assists local agencies when the expertise and maneuverability of motorcycles are needed for traffic-related issues.

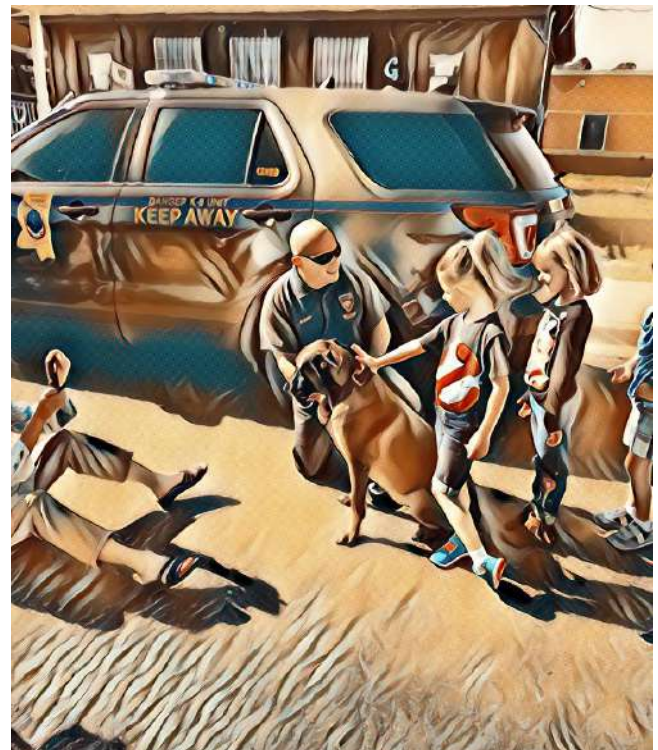
The MHSP Honor Guard provides a professional unit for special events such as funerals, memorial services, and formal law enforcement graduation ceremonies.

The Crime Stoppers Division helps local law enforcement across the state deter and solve crime through the creation of the local Crime Stoppers Program. Local Crime Stoppers programs are usually established and operated as not-for-profit organizations and are managed by a volunteer board of directors whose responsibilities include fundraising and paying rewards to people who anonymously call in information that helps solve crimes in their local communities. Currently, there are 33 active local Crime Stoppers programs. The Legislature finds that crime determent is a statewide concern and that utilizing cost effective tools - like the community Crime Stoppers program - helps law enforcement protect our communities, deter and fight crime and involve the community as a whole.



DRIVER SERVICES

Servicing customers in many different capacities, the Driver Services Bureau remains committed to providing positive customer service in the issuance and validation of credentials for the citizens of this state. It is our purpose to provide an efficient and effective model of services concentrating on proficiency, excellence and professionalism.

Driver Services maintains over fifty permanent and travel service locations throughout the state. Serving approximately three million customers per year, a staff of 152 Driver License Examiners are responsible for the examination and verification of all documents presented for credential issuance. Additionally, they conduct road tests, vision tests, as well as knowledge tests for regular and commercial licenses. Sixteen sworn officers protect the safety of citizens and employees in these Driver Services stations.

Other divisions of the Driver Services Bureau are less visible to the general public, but serve the needs of the citizens of this state as well. The Driver Records Division maintains all driving records for our citizens and diligently coordinates administrative actions and court actions that pertain to our citizens' driver license records. The Firearm Division handles the issuing of gun permits as legislated as well as security guard permits. The Motor Vehicle Tint Division serves the citizens by providing tint stickers to stations that check tint set by state statute and issues stickers accordingly. The Security Compliance Division's primary focus is to ensure that all credentials dispensed are properly issued using correct and valid documents. Also Audit, Online CDL Medical Cards, Title VI/ADA Compliance, Fraud/Identity Theft and SAVE (Non-US Citizens) status verifications are performed.

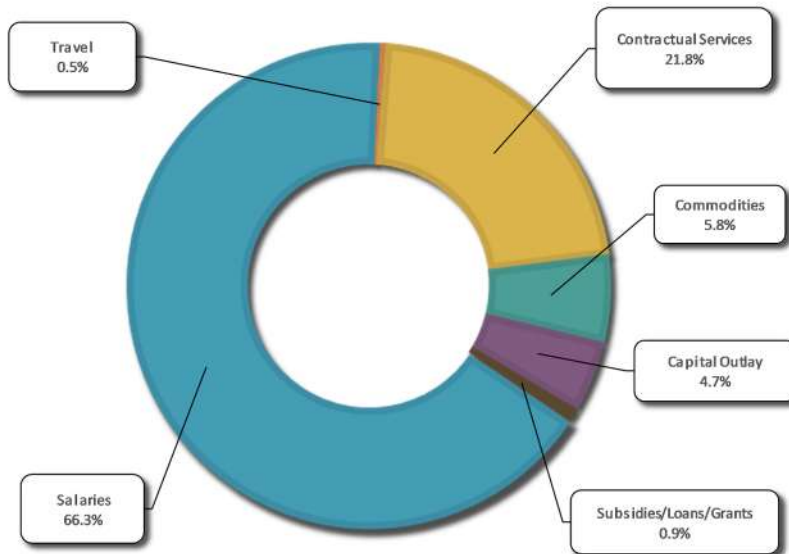
Our vision is to always evolve as an organization; to employ new and innovative measures and strategies that improve customer service, enhance the security of credentials, foster staff development and satisfaction, streamline agency procedures, and promote clear and timely communication.

DRIVER SERVICES ACCOMPLISHMENTS

- ▶ Driver Records Division has participated in the pilot launch of Mississippi's modernization project replacing the current mainframe integrated driver records administration and credential issuance system with the D360 system. D360 will ensure compliance with all federal Real ID requirements and will install an integrated driver records administration, driver license, identification card issuance and credentialing solution. Driver Records personnel have participated in training on the new system and have successfully completed pilot operations of all components. The modernized system provides improvement of the quality and security of driver license issuance and credentialing processes.
- ▶ Participation in the updated Driver License project to ensure compliance with all existing federal Homeland Security requirements for card security and protection against counterfeit. Currently issued through on-line and Kiosk renewals, the security-enhanced Driver License will be available through over-the-counter transactions within the next year.
- ▶ Implemented the standard telephone dialogue to improve and enhance customer experience when contacting the Driver Services Bureau.

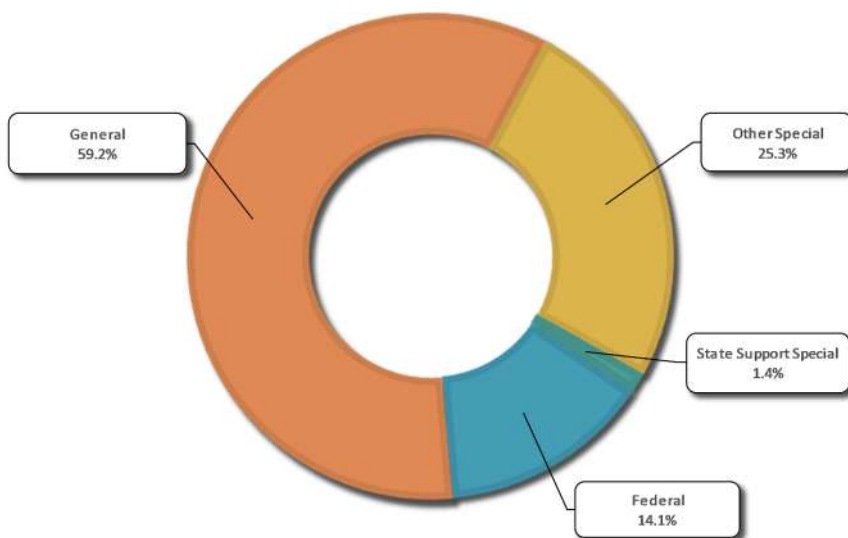
MISSISSIPPI HIGHWAY SAFETY PATROL FINANCIAL SUMMARY

MISSISSIPPI BUREAU OF NARCOTICS

The mission of the Mississippi Bureau of Narcotics (MBN), which was created by statutory authority in 1971, is to provide for the public's safety by reducing the availability of illicit controlled substances. This reduction is accomplished through comprehensive statewide enforcement initiatives supported by strategic planning and training and by working with federal, state and local law enforcement and regulatory agencies inside and outside the State.

ADMINISTRATION

An executive director appointed by the commissioner of the Department of Public Safety heads the MBN. The deputy director–chief of enforcement oversees investigations, while the lead attorney/chief of staff oversees administration; both report to the executive director.

The MBN administrative division, with 41 civilian personnel this report period, provides support services that ensure the agency is in compliance with departmental, state and federal regulations. It does so through its internal affairs, public relations, fiscal, personnel and property offices as well as through information, technical, communications and fleet services.

The MBN legal division is composed of a chief counsel and three senior attorneys, who provide consistent and efficient legal recommendations to the agency's three enforcement regions; a paralegal and a paralegal-intelligence analyst.

ENFORCEMENT

The MBN is engaged in a number of statewide drug enforcement initiatives designed to combat the possession, distribution and manufacture of controlled substances, as well as the illegal acquisition, prescribing and dispensing of pharmaceuticals.

Agency initiatives are implemented through overt and covert investigations. Such investigations involve working with health-care regulators as well as the use of wiretaps, warrants, controlled deliveries, highway and hostel interdiction operations, parcel interceptions, street sweeps and agents assigned to federal task forces.

Enforcement, with 103 sworn agents this period, is managed through three geographical regions with nine district offices, three special enforcement units and three quasi-enforcement units.

ENFORCEMENT REGIONS AND DISTRICTS

- ▶ Northern Region - Greenwood, Oxford, Tupelo and West Point district offices
- ▶ Central Region - Jackson and Meridian district offices
- ▶ Southern Region - Gulfport, Hattiesburg and McComb district offices

SPECIAL ENFORCEMENT UNITS

Gulf Coast High Intensity Drug-Trafficking Area (GCHIDTA) Mobile Deployment Team

This team conducts street sweeps, interdiction operations at hostels and common carriers, as well as drug and human trafficker investigations. It also provides additional drug enforcement for the Jackson metropolitan area.

There are 31 enforcement initiatives in the GCHIDTA, and the Mobile Deployment Team is the only one in Mississippi that does not have a federal lead. It is led by the MBN, which leads the entire GCHIDTA in total arrests.

Pharmaceutical Diversion

The MBN has a three-prong strategy to deal with the proliferation of pharmaceutical abuse:

1. DEA-MBN Tactical Diversion Squad - MBN agents are dually assigned duty at the U.S. Drug Enforcement Administration (DEA) to investigate cases involving the illegal prescribing and dispensing of prescription drugs.
2. Statewide Inter-Agency Diversion Unit - This unit works with local criminal justice, law enforcement and regulatory agencies to investigate pharmacy burglaries as well as with pharmacists in loss prevention training.
3. District Inter-Agency Diversion Unit - Agents in this unit investigate diversion of prescription drugs by fraud and work with regulatory agencies to thwart prescription drug misuse.



Domestic Cannabis Eradication/Suppression Program

Agents who work with this program locate and destroy domestically cultivated marijuana in conjunction with the Mississippi National Guard Counter Drug unit, state Department of Public Safety air operations unit, DEA and local law enforcement. In addition, these agents intercept parcels suspected of containing marijuana in cooperation with U.S. postal inspectors and major commercial parcel delivery companies.



QUASI-ENFORCEMENT UNITS

Evidence Management

This unit stores all MBN drug evidence; retains custody of evidence pending trial; destroys evidence for federal, state and local agencies; provides drugs for statewide K-9 training; assists local agencies in establishing protocols for evidence storage; and coordinates the statewide drug take-back program.

Criminal Intelligence

Agents and intelligence analysts assigned to this unit collect, collate and disseminate criminal intelligence and statistical data (both internally and externally); assist field agents with the processing of arrested drug suspects; compile the Mississippi drug threat assessment; maintain all confidential informant files; and maintain the agency case management system.

Training: Drug Education

Personnel with drug-education duties processed and responded to more than 160 requests for public appearances from law enforcement agencies, educational institutions and community organizations, reaching audiences totaling more than 19,600 adults and youth.

MBN destroyed numerous controlled substances, documents and other items for state and local entities.

Listed by weight or quantity, these items included:

ENFORCEMENT BRIEFS

Gulf Coast Prescription Drug-Trafficking Organization Dismantled

Upon receiving information that employees of a south Mississippi hospital were forging prescriptions, the DEA and MBN in February of 2016 began investigating what was discovered to be a Gulf Coast pharmaceutical drug-trafficking organization (DTO).

After an extensive investigation, in May of 2017, the agencies obtained more than a dozen state arrest warrants for acquisition of controlled substances by fraud for members of the organization and arrested 14 suspects. In the continuing investigation, federal prosecutors received a true bill on a 41-count indictment for 12 members of the DTO in June of 2017, while the MBN obtained five additional state warrants for other members. Subsequently, the DEA, MBN and U.S. Probation executed the federal and state warrants, arresting 16 suspects and seizing two vehicles, one in California.

Operation Return to Sender Nets 21 Suspects, \$136K, 29 Weapons, & Variety of Drugs

Last year the MBN in conjunction with federal, state and local law enforcement agencies in south Mississippi intercepted numerous international and domestic mail parcels containing illegal drugs in Operation Return to Sender. These efforts resulted in 21 felony arrests on 29 felony charges as well a wealth of intelligence that could aid in other investigations.

Seizures stemming from the operation include: 594 dosage units, five gallons and almost ten pounds of steroids; 110 pounds of marijuana; approximately 15 pounds of methamphetamine; 3,648 dosage units of the synthetic opioid Tramadol; approximately 17 pounds of synthetic cannabinoid; approximately 11 pounds of THC edible candy; 117 dosage units of THC oil; 46 grams of THC wax; 426 dosage units of methadone; 8,088 dosage units of various prescription medicines; 393 dosage units of the opioid oxycodone; as well as more than \$136,570 in cash and 29 firearms (including a stolen one).

Agents Infiltrate Drug-Trafficking Organization Operated by Husband and Wife

Working with federal, state and local law enforcement from June 2014 to February 2017, MBN agents investigated a large-scale methamphetamine distribution organization operated by a Benton County husband and wife. Agents learned the drug was obtained from a California supplier and distributed in Alcorn, Benton, Tishomingo and Tippah counties in Mississippi as well as in the surrounding states of Alabama, Arkansas and Tennessee.

In the course of the undercover investigation, agents purchased approximately 34 pounds of methamphetamine and seized \$42,000 in cash. Also, a search warrant executed at the ringleader's residence uncovered approximately a pound-and-a-half of methamphetamine, more than \$4,800 in cash, stolen property and 11 firearms along with ammunition.

Hattiesburg Methamphetamine Organization Dismantled; 8 Suspects Arrested

From fall of 2014 to date, working with federal, state and local law enforcement agencies, the MBN dismantled a Hattiesburg drug-trafficking organization that distributed large quantities of crystal methamphetamine throughout southern Mississippi. Law enforcement officers arrested eight individuals involved in distributing and selling methamphetamine obtained from a California supplier in Operation Red Dollar.

Items seized in significant quantities by agents during the investigation include more than \$253,000 in cash and other assets, nearly 114 pounds of methamphetamine, approximately a half-pound of black tar heroin, a pound of marijuana and three weapons.

Operation High Life Could Yield As Many As 35 Federal and State Indictments

A joint federal and state drug investigation code-named Operation High Life in east-central Mississippi shows the drug-trafficking organization (DTO) imports significant quantities of cocaine, methamphetamine and high-grade marijuana into the area. The DTO's identified suppliers are based in Texas. In addition, it has established links to Atlanta, Georgia and Mobile, Alabama.

To date, agents have seized approximately 73 pounds of methamphetamine, almost 90 pounds of marijuana, more than two pounds of cocaine, 380 dosage units of assorted prescription drugs and more than \$160,000 in cash. And by fiscal year's end, agents anticipate the indictment of 10 to 15 in-state and out-of-state suspects in federal court and 10 to 20 more in state court.

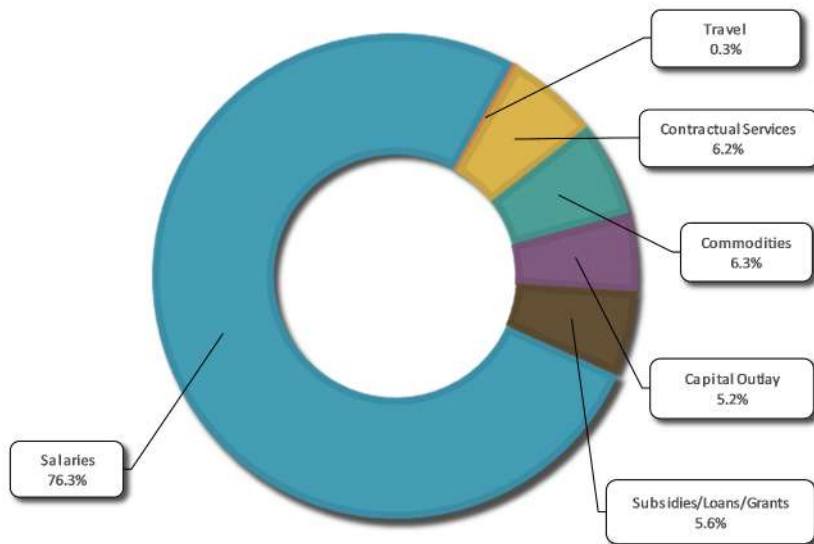
MAJOR DRUG SEIZURES

Drugs seized in the most significant quantities this report period include:

- ▶ Anabolic steroids: 2,863 dosage units
- ▶ Cocaine: 143 pounds
- ▶ Depressants, including Valium and Xanax: 5,073 dosage units
- ▶ Heroin: 1.5 pounds
- ▶ Marijuana (processed): 1,083 pounds
- ▶ Marijuana plants: 427
- ▶ Methamphetamine: 138 pounds
- ▶ Opioids (including hydromorphone, oxycodone and hydrocodone): 11,139 dosage units
- ▶ Synthetic cannabinoids, including spice: 22 pounds

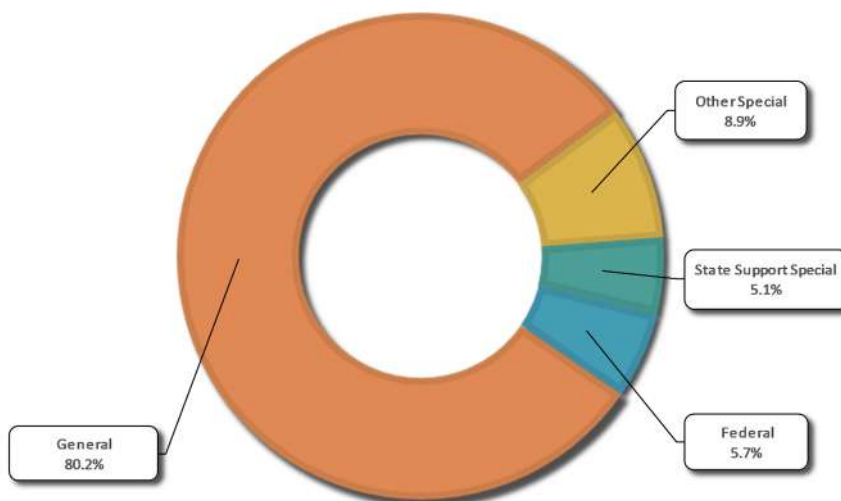

MISSISSIPPI OFFICE OF HOMELAND SECURITY

MISSION

The mission of the Office of Homeland Security (MOHS) is to partner with federal, state and local emergency personnel during both man-made and natural disasters, as well as working to prevent, protect, and respond to threats and/or acts of terrorism within our state. This office acts as the nexus for information sharing through its direction of the Mississippi Analysis and Information Center (MSAIC) and leads efforts in “All-Hazard” prevention, preparedness, and response, by continuing to foster strong partnerships across professional response disciplines. The office furthers the education for the citizens of Mississippi through awareness and outreach efforts. These efforts are accomplished through training, equipping, and informing the populace about the steps necessary to keep themselves and their communities vigilant and prepared.

DIVISIONS

The Mississippi Office of Homeland Security has two major divisions – the Home Office and the Mississippi Analysis and Information Center (MSAIC). Within the Home Office, the units include Grants, Training, Community Service, Public Awareness and Special Projects. Within MSAIC, the units include Intelligence Analysis, Law Enforcement Liaison, Gangs, Critical Infrastructure Protection and Cyber Security.

Mississippi Task Force

MOHS utilizes federal funds to organize, equip, train, and exercise locally staffed, state-wide homeland security specialized response teams incorporating law enforcement, fire service, and emergency management disciplines. These various homeland security response teams are staffed from county emergency management agencies, fire, sheriffs and police departments from across the state. Participating agencies designate select individuals to staff the various homeland security response teams. These individuals receive the required specialized training and exercise, developmental skill-set certification and credentialing requirements.



National Domestic Preparedness Consortium (NDPC)

MOHS continues to hold a seat on the 9 member NDPC advisory council. The NDPC is a partnership of several nationally recognized organizations whose membership is based on the urgent need to address the counter-terrorism preparedness needs of the nation’s emergency first responders within the context of all hazards including chemical, biological, radiological, and explosive Weapons of Mass Destruction (WMD) hazards. MOHS uses this resource to co-sponsor the U.S. Attorney’s State and Local Anti-Terrorism Training (SLATT) for continued statewide terrorism awareness training.

MLEOTA, Meridian Training Facility and MS State Fire Academy

MOHS continues to fund the Mississippi Law Enforcement Officers' Training Academy (MLEOTA), the Meridian Training Facility and the Mississippi State Fire Academy to include Task Force and Force Protection programs as well as other law enforcement training when able. Training courses include:

- Fundamentals of Search and Rescue
- Advanced Search and Rescue
- Rope I and II
- Confined Space Search and Rescue
- Collapsed Structure Search and Rescue
- Mobile Field Force Training

K9 Program

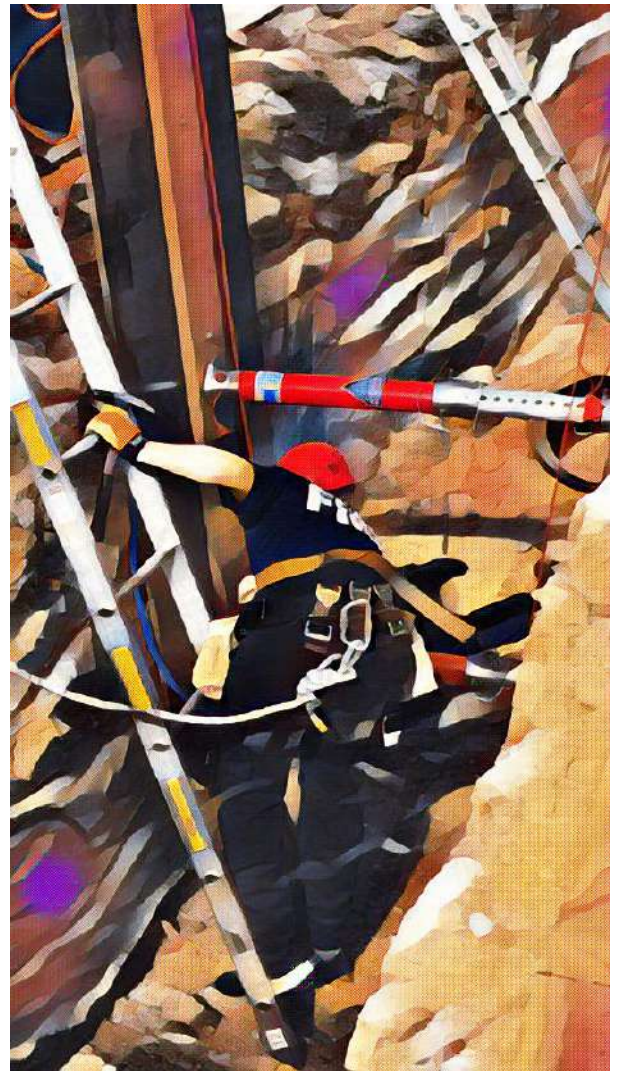
The K9 program seeks to do two functions. One is to fund an Explosive Detector Dog (EDD) K9 for an agency to work in a specified geographical location. The other is to work with and fund an agency/department that has K9 trainers on staff to support the concept of training dogs that come from a kennel/shelter to become explosive detection K9's at a fraction of the cost so that we may keep sufficient K9 teams available for special events and day-to-day explosive support for bomb threats.

Force Protection / LE Task Force

The Force Protection/Law Enforcement Task Force program is based on the same project developed and currently administered by the Louisiana Sheriff's Association. Desiring to mirror their Law Enforcement Task Forces, our office met and proposed the framework and support jointly to the Mississippi Sheriffs Association (MSA) President and the Mississippi Association of Chiefs of Police (MACP) President. The MSA and MACP have adopted the MOHS proposal. Preliminary training will start in December of 2017.

Bomb Team Project

MOHS works with four bomb squads across the state to maintain an operational capability to respond to explosive incidents throughout the state in a short amount of time. The four bomb squads are funded and trained to have the capability to respond to any environment in Mississippi and conduct render safe procedures. MOHS, in conjunction with the Bomb Squads and State and Federal Partners, have established a state working group that addresses explosive issues, training equipment and response protocols. Through this working group, a state Bomb Plan has been developed and Explosive Detector Dog Teams have been brought into this group to address ongoing K9 support.



ALPR Program

During the past four years, the Mississippi Office of Homeland Security has been building out a statewide Automated License Plate Recognition System (ALPR) for information sharing. Currently, this office has purchased nineteen (19) cameras in locations throughout the state and one (1) trailer unit that collects license plate information on each vehicle as it passes the camera locations. These locations are operational 24 hours a day every day. The intent of the statewide ALPR system is to utilize one system to assist and share information with our state and local law enforcement partners. Numerous local agencies have purchased their own systems that operate on our server to increase information sharing across the state.

UAV Program

The MS Office of Homeland Security acquired twelve (12) Unmanned Aerial Vehicles (UAVs), which are located strategically throughout the state. The UAV's are equipped with "real time" camera systems and are an asset for search and rescue operations, law enforcement support, hazmat situations, storm damage assessment, and explosive ordinance teams at a fraction of the cost of conventional aircraft. These aircraft are available to assist our state and local partners throughout the state within the guidelines of our policy and procedures. MOHS will continue to expand this program to better serve the needs of this state.

Citizen Corps Program

The mission of Citizen Corps Program (CCP) is to harness the power of every individual through education, training, and volunteer service to make communities safer, stronger, and better prepared to respond to the threats of terrorism, crime, public health issues, and disasters of all kinds." The Citizen Corps mission is accomplished through a national network of state, local, and tribal Citizen Corps Councils.

Currently the Mississippi CCP consists of:

- ▶ One (1) State Council,
- ▶ Eleven (11) County Councils, and
- ▶ Nine (9) Local Councils.

Citizen Corps Partner Programs include:

- ▶ Thirteen (13) Volunteers In Police Service,
- ▶ Five (5) Medical Reserve Corps,
- ▶ Fifteen (15) Fire Corps Programs,
- ▶ Sixty-three (63) Community Emergency Response Teams, and
- ▶ More than 160 Neighborhood Watch programs.

MS Youth Preparedness Initiative (MyPI)

MyPI is a 5 to 10 week program offered through Mississippi State University's Extension Service in which Mississippi teens (aged 13-19) complete the Homeland Security certified Teen CERT training, CPR and AED certification.

Homeland Security Information Network (HSIN)

The Homeland Security Information Network (HSIN) is a secure network for homeland security mission operations to share "sensitive but unclassified" information. Federal, State, Local, Territorial, Tribal, International and Private Sector homeland security partners use HSIN to manage operations, analyze data, send alerts and notices, and in general, share the information they need to do their jobs.

The Mississippi HSIN program currently consists of thirteen (13) Communities of Interest; including Law Enforcement, MSAIC, Emergency Management, Critical Infrastructure, MS Information Liaison Officers, VOAD, MS Department of Health, MS Department of Education and the MS Alliance of Emergency Preparedness Laboratories.



See Something, Say Something Campaign and App

A contract is currently in place with Supertalk Radio (Telesouth) featuring the “See Something, Say Something Campaign” and providing linkages to MOHS and MSAIC. This campaign, approved nationally by the U.S. Department of Homeland Security, informs citizens on how to report suspicious activities as well as what items to take notice of when submitting a report. MOHS also launched a “See Something, Send Something App” that connects users via mobile phone to MSAIC and allows them to easily report suspicious activities including photographic evidence of the activity/scene. These reports are sent directly to MSAIC for verification. This app is incorporated into PSA spots for statewide radio broadcast. In addition, the MOHS website, HSIN, MOHS Facebook, and Twitter have been geared towards ease of information flow.

MS Analysis and Information Center

The purpose of the Mississippi Analysis and Information Center (MSAIC) is to provide Mississippi with a centralized location for the gathering, analysis, and sharing of information from local, state, tribal and federal resources to prevent criminal activity including acts of terrorism or other threats to public safety. MSAIC serves as the integrated multi-discipline sharing network for situational awareness and is a key component of the jurisdiction's homeland security and crime prevention efforts. It is the state's federally recognized Fusion Center.

MSAIC Goals:

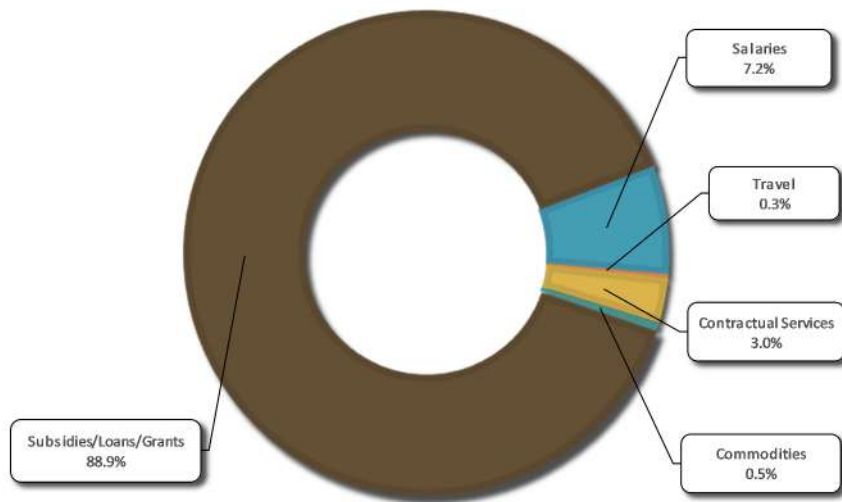
- ▶ Maximize Mississippi's law enforcement and public safety agencies ability to detect, prevent, apprehend and respond to criminal and terrorist activity
- ▶ Support an all-crimes, all-hazards, all-threats approach to intelligence
- ▶ Collect, analyze, disseminate real time criminal intelligence information to operational and executive elements
- ▶ Reduce duplication of effort
- ▶ Support intelligence led policing and national security strategies/initiatives through the analysis and dissemination of information collected from across Mississippi and the U.S.
- ▶ Support critical infrastructure protection



Due to the wide range of resources available and the support provided to law enforcement by the MSAIC, investigative matters have been enhanced and in many cases have led to successful conclusions. The MSAIC utilized resources to assist law enforcement on all levels and has provided information to law enforcement with investigations in over 1,400 cases.

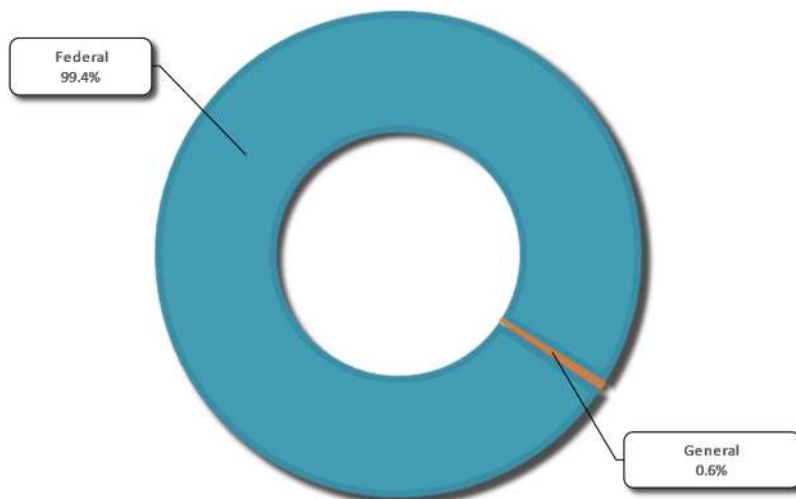

MISSISSIPPI FORENSICS LABORATORY

The mission of the Mississippi Forensics Laboratory is to provide the highest quality objective services in the recognition, collection, preservation, scientific analysis and interpretation of physical evidence in the pursuit of truth within the criminal justice system. The MSFL serves close to 400 local, county, state and federal law enforcement agencies through the examination of physical evidence and the presentation and interpretation of those findings for investigators and as experts in court.

Management at the Mississippi Forensics Laboratory is committed to good professional practice and to the quality of testing in servicing its customers. The Laboratory is an ANAB - International accredited laboratory system, with a central full-service laboratory in Pearl and three regional laboratories located in Batesville, Meridian and the Gulf Coast.

The MSFL plays a major and significant role in the investigation and adjudication of crime in our state by providing the highest quality scientific forensic analysis of evidence for law enforcement and judicial stakeholders in Mississippi. The MSFL is the only publicly-funded forensic laboratory in Mississippi that is ISO accredited and our commitment to excellence of services was validated this year by a recent accreditation assessment resulting in full compliance to their rigorous standards.

During the FY 2017 fiscal year, the MSFL received 20,700 cases containing 23,490 requests with completion of 22,960 requests from more than 400 state, local and federal agencies. These requests were completed by approximately 60 expert scientists who received approximately 3,000 subpoenas for court testimony across the state.

OBJECTIVES:

- I. Perform forensic examinations in an accurate manner utilizing scientifically accepted techniques.
- II. Render opinions and conclusions strictly in accordance with the facts in the case and only to the extent justified by the evidence.
- III. Provide expert testimony in a clear, concise manner and within the constraints of specific expertise and competence.
- IV. Actively participate in proficiency testing.
- V. Perform duties in a professional manner worthy of the confidence of the public.
- VI. Strive to maintain and improve the skills/knowledge of the staff in order to keep current with advances/standards in the respective disciplines.
- VII. Increase public awareness of the role of forensic science within the criminal justice community.
- VIII. Provide training to the criminal justice and forensic community.
- IX. Promote the development of employees through participation in organizations, research and publications.

BIOSCIENCE DIVISION

The Bioscience Division consists of Serology, DNA and CODIS for the State of Mississippi. This division currently has a Serology section in all four laboratories in the state. The Serology section is responsible for analyzing evidence for the presence of any biological material (e.g., blood, semen, saliva and skin cells). The DNA and CODIS sections are housed in the main laboratory in Pearl.

The DNA section is responsible for characterizing the biological material from crime scene and evidentiary samples and comparing them to known reference samples from victim and suspects. The CODIS section is responsible for maintaining the State of Mississippi's DNA database, which consists of DNA profiles from crime scene samples, evidentiary samples, convicted felon samples, and qualifying arrestee samples. The national Combined DNA Index System - or CODIS - blends forensic science and computer technology into a tool for linking violent crimes. It enables federal, state, and local forensic laboratories to exchange and compare DNA profiles electronically, thereby linking serial violent crimes to each other and to known offenders.



In 2017, one of the major achievements for the Bioscience Division was the collection, processing, uploading and searching of arrestee samples in CODIS as part of Katie's Arrestee Law, which proved to be a valuable tool in solving crimes - even cold cases. The 1996 cold case featured on *Forty Eight Hours* as the "Ghost of Mississippi" was solved after the collection of an arrestee's samples. The collection of arrestee samples is just another tool in our box for solving unsolved crimes within our state and in other states. To date we have solved 702 unsolved cases using CODIS. Currently we have over 118,000 profiles in the CODIS database that are being searched weekly against other profiles in the state and nationally.

The Bioscience Division has demonstrated a commitment to the state by providing the highest quality of DNA work that is allowed to be entered into CODIS. This division successfully completed an external DNA Quality Assurance Audit with no findings and an external NDIS (National DNA Index Systems) DNA maintaining minimal to no findings on external mandated FBI DNA audits - which allows us to maintain our national accreditation and continue participating in CODIS.

ANALYTICAL DIVISION

The Analytical Division of the MSFL is divided into four distinct sections: the Drug Analysis Section; the Toxicology Section; the Implied Consent Section; and the Trace Analysis Section.

Drug Analysis Section

The Drug Analysis Section is located in all four branches of the Mississippi Forensics Laboratory. The section currently consists of 14 case working analysts. One analyst completed training in November of 2016 and one in February of 2017. In fiscal year 2017, the drug section received 11,315 requests for analyses with a total of 21,996 submissions. The section was able to complete and report 11,027 requests and a total of 21,507 submissions. Three types of requests from law enforcement agencies statewide are performed - controlled substances, clandestine laboratory and general chemistry examinations.

Controlled Substance Examinations are by far the most common request received which involves examining items of evidence such as, but not limited to, cocaine, methamphetamine, pharmaceuticals, opioids, and

marijuana. Law enforcement personnel are then assisted in identifying new substances in the every changing battle against illegal drugs; i.e., synthetic cannabinoids and synthetic cathinones. Both are controlled substances based on their chemical structure and small changes to the chemical compound produce a new drug for law enforcement officers to have to contend with. This makes it difficult to list the compounds by name in the statutes. A similar problem exists with fentanyl compounds. We are currently seeing several analogues of fentanyl, which are extremely potent opioids, and require extra precautions when analyzing. The lab provides assistance to law enforcement in identifying these ever changing compounds and informing officers of their controlled status. We also identify compounds that are not currently controlled, but are being watched in order to determine if they need to be added to the list of controlled substances. In the past fiscal year, the MSFL received 11,290 requests containing 21,886 submissions with controlled substance analysis requests. Completed requests totaled 10,989 including 21,306 submissions.



The second type of request is Clandestine Laboratory Examinations. This request involves examining items of evidence for the presence or absence of any controlled substance as well as any precursor or listed chemicals associated with the clandestine manufacture of a controlled substance. The most common type of clandestine laboratory in the state is for the illicit production of methamphetamine. The section assists law enforcement by identifying these chemicals so as to assist with the investigation. Some of the common substances seen are starter fluid, camp fuel, ammonium nitrate, sulfuric acid, hydrochloric acid, sodium hydroxide, and various other fertilizers. To a lesser extent, the

laboratory has in the past received dimethyltryptamine (DMT), phencyclidine (PCP), and synthetic cannabinoid laboratories. These each propose specific challenges to both the laboratory and law enforcement due to the hazardous nature of these chemicals and the changing methods of illicit drug production. In the past fiscal year, the laboratory received 24 requests and 104 submissions associated with clandestine laboratory analysis request. Completed requests totaled 34 including 191 submissions.

The third type of request is General Chemical Analysis. This request involves general chemical compound identification. In most cases, this type of request is for non-controlled drugs and poisons that officers need to have identified. Poisons such as pesticides are analyzed to assist in death investigation cases. This request is generally considered a “catch all” due to the fact we will assist law enforcement in a wide variety of chemical examinations on an as needed basis. In the past fiscal year, the laboratory received 2 requests and 4 submissions associated with general chemical analysis request. The section completed 4 requests and 8 submissions associated with general chemical analysis request.

The Drug Analysis Section of the Mississippi Forensics Laboratory strives to assist law enforcement throughout the state in the effort to combat the illicit drug possession, manufacturing, and trafficking in any and all manners possible. We provide the law enforcement officers and district attorneys with the information they need as to the identity of the drugs seized around the state to aid in the prosecution of drug cases. We also provide results of evidence found to be not controlled so as to equally assist law enforcement and prosecuting attorneys with information needed to determine appropriate adjudication. We strive to complete our examinations as quickly and accurately as possible with the resources available.

Toxicology Section

The focus of the MSFL Toxicology Section is to provide their customers (Mississippi law enforcement agencies and Mississippi courts) with forensic analytical testing. The services offered are blood and urine alcohol analysis and blood and urine drug screening for traffic related impaired driving cases. The goal of this testing is to provide information that aids in the determination of driving impairment in DUI (Driving Under the Influence of alcohol) and DUID (Driving Under the Influence of Drugs) cases. This service includes providing records and expert witness testimony when required.

Another focus of the MSFL Toxicology Section is to provide the Mississippi State Medical Examiner's Office (SMEO) with forensic analytical testing. These services are similar to those described above, but are expanded in terms of the types of samples tested, the different types of drugs, poisons and compounds screened for the goal of that information. Post mortem samples can include vitreous humor and other tissues such as brain, liver, kidney and muscle that require testing. The goal of this testing is to aid the ME's office in determining the cause of death in death investigation cases.



A major achievement for the Toxicology Section for FY2017 has been the completion of approximately 4,270 toxicology requests with a total of 10,658 submissions for their customers with an average turnaround time of 22 days. In addition, the section testified in courts across the state at least nine separate times.

Implied Consent Section

The focus of the Implied Consent (IC) Section is to provide their customers (Mississippi's law enforcement agencies and courts) with an evidential breath alcohol testing program. The services offered are the installation of breath alcohol testing instruments to law enforcement agencies across the state of Mississippi as well as the maintenance, repair, calibration and certification of these instruments. There are approximately 250 different locations across the state. The IC section provides training and certification to law enforcement for operation of breath alcohol testing instruments. The IC section also provides records and expert witness testimony when required by the courts.

Because of the commitment by the IC section to the state's alcohol breath testing, law enforcement has completed approximately 11,000 evidential breath tests in the last year. The section maintains the operator certification records and issues Intoxilyzer 8000 operator cards for approximately 3,000 to 4,000 law enforcement personnel.

Another focus of the IC section is the promulgation of the rules and regulations for the Ignition Interlock Device (IID) Program. The services offered are the certification of IID's, vendors and locations that provide IID service in the State of Mississippi. At this time, there are three approved vendors in the state with over 30 locations providing service.

Trace Analysis Section

The Trace Evidence Section currently has three full-time case working forensic scientists. The Forensic Laboratory in Pearl is the only trace evidence lab in the State of Mississippi and services all 82 counties in the State. Trace Evidence is responsible for analyzing gunshot residue, fire debris, glass and paint comparisons, hair and fiber exams and various other trace evidence samples. In FY2017, the Trace Evidence Section received 797 trace evidence cases to be analyzed and completed analysis on 705 cases.

CRIMINALISTICS DIVISION

The Criminalistics Division is made up of the Firearm/Tool Mark Section, the Latent Print Section, the Questioned Documents Section, Technical Assistance Section, and Quality Assurance Section.

Firearm/Tool Mark Section

The Firearm/Tool Mark Section of the Mississippi Forensics Laboratory examines firearms-related items of physical evidence submitted by law enforcement from state, local and federal agencies. These examinations include the microscopic comparisons of projectiles and casings to determine if they were fired from a particular firearm, serial number restorations, distance determinations and tool mark examinations. We currently have five examiners, two trainees and a NIBIN technician statewide. Four examiners are based at the main laboratory in Pearl and one examiner is based at the regional lab in Biloxi.

The Firearm/Tool Mark Section also utilizes the National Integrated Ballistic Information Network (NIBIN) which was launched in 1990 by the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF). To use NIBIN, firearm examiners and NIBIN technicians enter cartridge case evidence into the Integrated Ballistic Identification System (IBIS) units that are housed at the Mississippi Forensics Laboratories in Pearl and Biloxi. Irregularities found on the surface of the firing pin and breech, which are caused during the manufacturing processes, and continued use of the firearms impart marks onto the casings, which can then be used for identification purposes. The examiners use the IBIS unit to capture images of these irregularities as a preliminary screening process. Correlation results are then viewed to see if there is a possible case to case association. If a possible match is found, the physical evidence will be requested to confirm the lead for prosecution purposes.



NIBIN provides a unique opportunity to link cases involving the use of firearms and provides leads that would have otherwise been impossible without this technology. As part of a timely and comprehensive regional crime gun strategy, NIBIN is an integral crime gun intelligence tool that assists law enforcement agencies to identify, target and prosecute shooting suspects. Leads identified through the use of NIBIN can provide analysts and investigators with critical tactical and strategic information. Tactically, NIBIN leads can link shooting incidents more quickly and efficiently and provide real-time information, which enables investigators to identify and apprehend suspects before they can

commit additional crimes. Strategically, intelligence obtained through the use of NIBIN can aid in better understanding gun crime patterns, including gun sharing and trafficking. Every eligible firearm, as well as casings left at crime scenes, should be entered into NIBIN. When firearms are submitted to be test-fired and entered, they will correlate with previous and future entries. Therefore, it is crucial that expended cartridge casings from all crime scenes and eligible firearms are submitted, ideally within 24-72 hours of a shooting incident or firearm-related crime.

FY2017 saw a renewed emphasis in the NIBIN program by the Mississippi Forensics Laboratory, including hosting a "13 Critical Tasks Workshop" attended by twenty-two agencies. The "13 Critical Tasks Workshop" is based on the premise that the successful investigation of firearm related crimes is dependent upon the effective management of information found on the inside and on the outside of a gun. More specifically, topics were addressed relating to the firearms data used in microscopic comparisons and the identifying data for

crime gun tracing. The workshop assisted with pinpointing best practices and resulted in the formulation of strategies and tactics that foster collaboration between all the agencies. The principles taught on gun crime intelligence continued to be showcased in FY2017 by more than 1,200 entries into the NIBIN database encompassing law enforcement agencies throughout the entire state. Thirty-four leads were identified during this time, which linked cases across numerous jurisdictions - many of which would not have been recognized without this unified commitment to reducing violent crime.

Latent Print Section

The major focus of the Latent Print Section is to examine items of physical evidence for the presence or absence of latent prints and/or footwear/tire track impressions. Once physical evidence has been examined and latent prints and/or footwear/tire track impressions have been found, they are then compared to any known exemplars that were submitted in the case. If no known exemplars were submitted in the case, the latent prints and/or footwear/tire track impressions would be searched through local, internet or computerized databases.



Some of the databases used are:

- ▶ Automated Fingerprint Identification System (AFIS) - biometrics system used for in-state criminal identification purposes
- ▶ Integrated Automated Fingerprint Identification System (IAFIS) - national fingerprint identification and criminal history system
- ▶ Local Footwear Database - database created in-house of shoes worn locally
- ▶ Internet Databases - different websites for shoes such as Zappos.com
- ▶ Shoeprint Image Capture and Retrieval System (SICAR) - database of approximately 37,000 shoe/boot outsoles
- ▶ Tread Assistant - database of tire tread designs

Major achievements for FY2017 by program or areas of responsibility include the identification of numerous John/Jane Does. The unknown fingerprints were submitted from the State Medical Examiner's Office and searched through AFIS and IAFIS. In addition, the database identified suspects in cases in which law enforcement had no suspects.

Questioned Documents Section

The Questioned Documents Section (QD) examines forensic evidence related to documents whose authenticity is in doubt or is questioned. Approximately 80% of the examinations involve the comparison of questioned to known handwriting for identification. Other commonly requested document examinations include the analysis of indentations, obliterations & alterations, inks (non-destructive and destructive), paper fibers, sequence of writing strokes, counterfeit documents (drivers licenses, ID cards, currency, etc.), staple holes, charred documents, water soaked documents, et al. Instruments used in the creation or marking of documents may also be examined, including copy machines, facsimile machines, printers (e.g., ink jet, electrostatic, thermal, wax transfer, offset, dye sublimation, screen, or intaglio), rubber stamps, and typewriters.

The focus of the QD Section is to provide the citizens of Mississippi with valid, accurate, and up-to-date Forensic Document examinations. The QD Section of the Mississippi Forensics Laboratory (MSFL) is directly involved with the creation of consensus standards used in the Forensic Document field. This involvement stems from membership in the Organization of Scientific Area Committees (OSAC). The OSAC is the first organization to allow multiple forensic disciplines to come together and share ideas during the standards development process. The MSFL also has representation in the newly formed Academy Standards Board (ASB) through the Forensic Document Examination consensus body. The ASB is the standards development organization created by the American Academy of Forensic Sciences specifically for the field of forensic science. Standards written by the OSAC will be vetted and published by the ASB.

The ASB and OSAC are the result of comments and criticisms raised in the 2009 National Academy of Sciences (NAS) report. Since the NAS report was published, funding for research and education in the forensic sciences is at an all-time high. Many of the validation and ground truth studies currently being funded by the National Institute of Justice would not exist otherwise.

While this involvement may not initially appear to be directly related to the state of Mississippi, it places the Mississippi Forensics Laboratory in the forefront of where forensic science is headed. No matter what changes occur in the near future, the State of Mississippi will have a seat at the table.

Technical Assistance Section

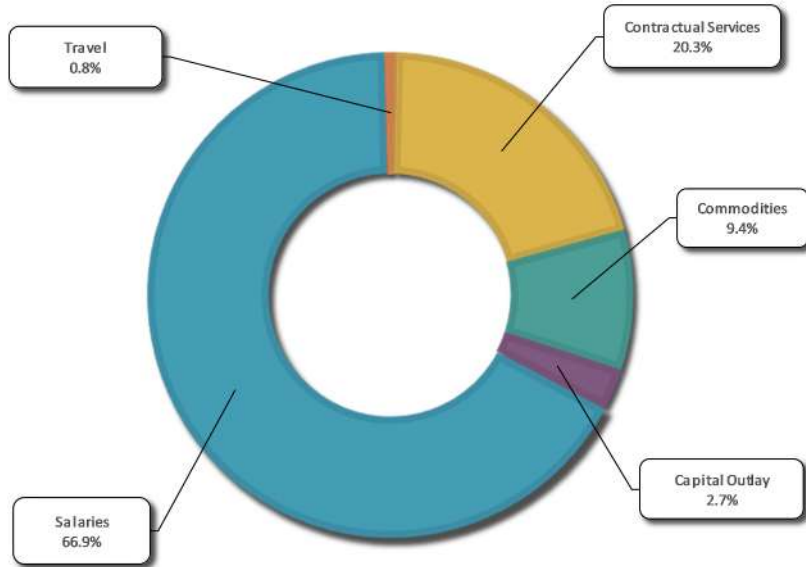
The Technical Assistance Section (TAS) at the Mississippi Forensics Laboratory (MSFL) is primarily responsible for receiving and maintaining evidence involved in criminal cases throughout the state. Evidence and records are received and stored at all four labs. This section also files records and acts as the MSFL liaison to all law enforcement agencies across the state. TAS is responsible for the transfer of evidence between law enforcement agencies and Forensic Scientists employed by the MSFL who are assigned to work them. In addition, TAS transfers evidence between each lab weekly. Currently, there are eleven staff members that are assigned to TAS - two of which are currently eligible for retirement. For 2016, TAS employees received 25,361 cases which contained 89,706 individual submissions. This averages out to be approximately four submissions per case.

Quality Assurance Section

The Quality Assurance Section is responsible for developing, implementing, and monitoring the quality system of the MSFL. This is done by writing policies and procedures that insure compliance with accreditation standards, conducting internal assessments and audits of every section of the laboratory, administering proficiency tests and competency tests for all case working analysts, maintaining personnel and training records for each employee, calibrating and maintaining records for all critical equipment, monitoring and evaluating expert witness testimony, determining when corrective actions are necessary and monitoring continued compliance with policies and procedures.

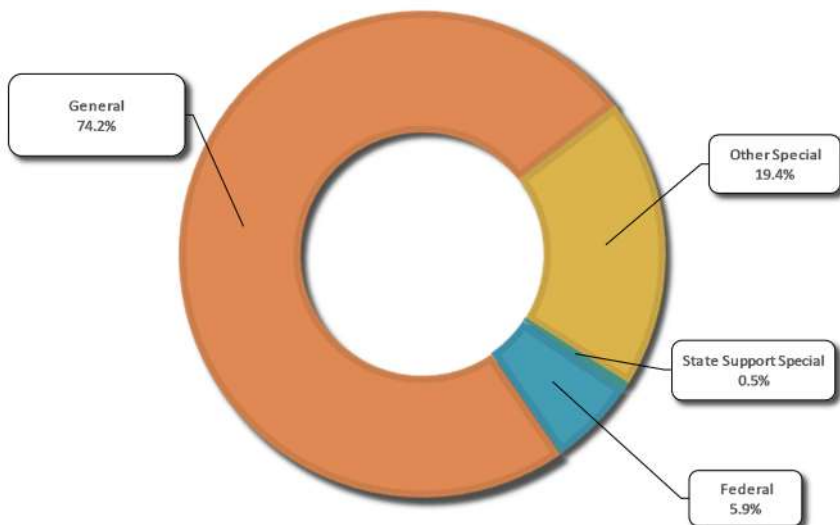

MISSISSIPPI STATE MEDICAL EXAMINER'S OFFICE

ME OBJECTIVES

- A. Perform forensic examinations in an accurate manner utilizing sound medical and scientific techniques.
- B. Render opinions and conclusions strictly in accordance with the facts of the case, and only to the extent offered by the evidence.
- C. Make and retain full records of all examinations conducted and conclusions drawn. These records are in sufficient detail to allow meaningful review and assessment of the conclusions by an independent person certified in the field of Forensic Pathology. Reports are prepared in which facts, opinions, and interpretations are clearly distinguishable. The reports clearly describe limitations of the interpretations and opinions presented.
- D. Offer continuing education to other agencies directly associated with death investigation. By providing this education, the office maintains an open line of communication and networking with these outside agencies. The goal of the education is to ultimately enhance the death investigation process. Proper training will enable the State to accurately monitor and investigate infant deaths, accidents, homicides, suicides, and drug-related deaths. In addition, the office certifies that each Coroner and Deputy Coroner has fulfilled their annual continuing education requirements.

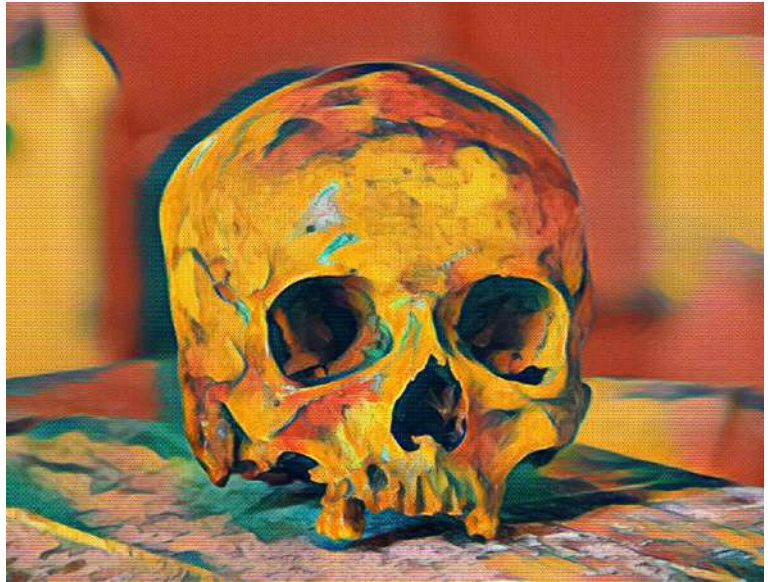
The mission of the Mississippi State Medical Examiner's Office (SMEO) is to assure that all deaths which affect the public interest are properly investigated, diagnosed, and reported. The types of deaths investigated by the SMEO include all deaths of children under the age of two years and all deaths occurring while in law enforcement custody. In addition, the SMEO investigates and examines deaths due to violence (such as suspected homicides and suicides), drug toxicity, work place accidents, infectious disease, natural disease, aviation and maritime deaths, elder abuse, and mass disasters. The State Medical Examiner's Office is also tasked with the identification of all unknown human remains, and individuals whose identifying features are distorted by trauma, fire, and/or decomposition (as mandated in Miss. Code Ann. §41-61-63).

Approximately 1,700 medicolegal postmortem examinations are performed each year by Forensic Pathologists, who are board-certified by the American Board of Pathology. To maintain licensing and/or certification, these physicians receive further education annually in current techniques, research, and opinions in Forensic Pathology as well as death investigation.

The SMEO also assures that all coroners and their deputies meet the required educational standards by providing a bi-annual 40-hour training course to all new officials and by offering continuing education courses in the most current forensic investigative techniques and procedures (as mandated in Mississippi Code Ann. §41-61-57). Eighteen individuals representing twelve counties successfully completed the SMEO's restructured 40-hour training course, and were certified as Deputy Coroners for their respective jurisdictions.



The Mississippi State Medical Examiner's Office services all of the counties in the state as well as the Choctaw Reservation. Currently, staffing includes three board-certified Forensic Pathologists. Efforts to recruit up to six additional board-certified Forensic Pathologists are on-going. The State Medical Examiner's Office has hired and trained two support staff who will relocate to the Gulf Coast Office as soon as a Forensic Pathologist has been hired to service the coastal region. The Gulf Coast Office is expected to perform up to 350 autopsies per year.



The State Medical Examiner's Office employs two Ph.D. Forensic Anthropologists who perform detailed examinations of human remains. These analyses include the development of biological profiles in order to facilitate an identification of unidentified skeletal remains, and a focus on traumatic injuries to help determine cause and manner of death and distinguish pattern of injury whenever possible. The anthropological team continues to work with the National Missing and Unidentified Persons System (NamUs) and multiple law enforcement agencies in an effort to obtain identifications for the unknown individuals whose remains are held at the SMEO. The office is establishing a human remains recovery team which can be deployed within the State of Mississippi to oversee exhumations and recoveries. Also, the office continues its development of a focused mass fatality management plan expected to complement the State Department of Health Fatality Management Annex and its parent Comprehensive Emergency Management Plan.

The Medical Examiner's Office has state-of-the-art, portable, digital dental radiographic equipment operated by our forensic technician staff to generate postmortem records for comparison with antemortem dental records. Since 2016, our consulting Forensic Odontologist has provided analysis on 45 cases in which the identity of the decedent was unknown; dental identifications using this technology were confirmed in slightly more than 50% of these cases. During the last quarter of the year the SMEO, in conjunction with the Mississippi Forensics Laboratory, was awarded Homeland Security grant monies to be applied toward the purchase of a Laser Scanner and software for use in recovery scene documentation and reconstruction.

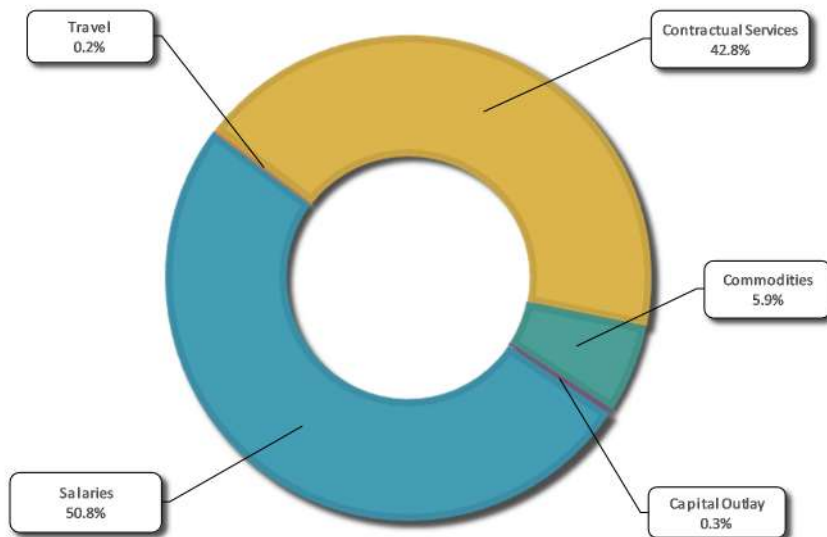
The Forensic Pathologists continue to provide detailed reports of their postmortem examinations to all District Circuit Courts within the State. Our physicians travel throughout the state on a weekly basis to provide expert witness testimony in the majority of homicide trials.

The Medical Examiner's Office was intricately involved in the investigation of synthetic cannabinoid (spice) related deaths. Mississippi was one of the first states in the country to experience mass overdoses of these powerful and dangerous designer drugs. The office collaborated with the Health Department, University of Mississippi Medical Center, and the State Crime Laboratory in analyzing data from synthetic cannabinoid overdoses and fatalities. Currently, the challenge continues with opiate and heroin overdoses and fatalities, which are reaching an all-time high.

The SMEO also works closely with The Mississippi Organ Recovery Association (MORA) to help provide much needed tissue and organs for transplantation. We are available for telephonic consultation with MORA and the Coroners to determine the extent and appropriateness of postmortem organ and tissue donation.

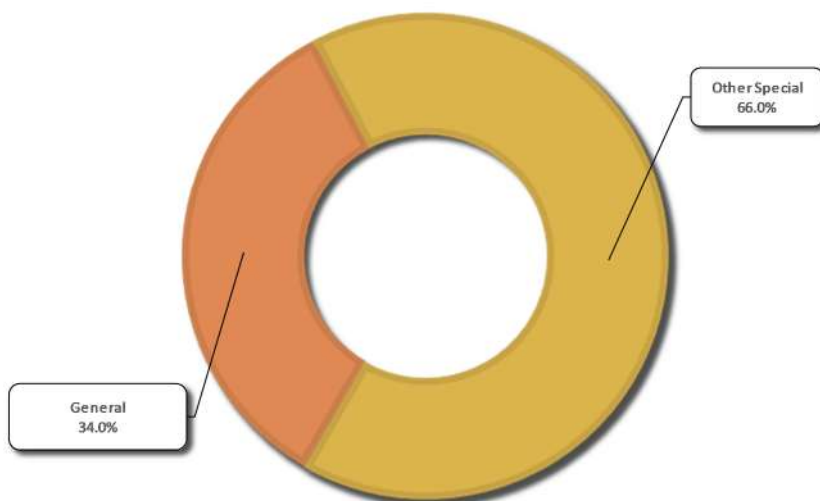

MISSISSIPPI LAW ENFORCEMENT OFFICERS' TRAINING ACADEMY



The Academy was established by the "Mississippi Law Enforcement Officers' Training Academy Law of 1964", Miss. Code Ann. § 45-5-1 (1972). This act declares that public welfare demands and the state public policy require proper and adequate preservation of domestic tranquility by the presence of sufficiently trained law enforcement officers on local and state levels and that the accomplishments of such an academy will preserve the present and prospective safety, morals, pursuit of happiness and general welfare of citizens of the State of Mississippi.

The academy is structured with a Director, Training Officer, Comptroller, Administrative Officer, and a Range Officer who insure the accomplishments of agency goals and objectives. The Training Officer is responsible for instructional staff and other areas of management. The Comptroller is responsible for the budget and accounting functions. The Administrative Officer is responsible for maintenance, hotel, kitchen and housekeeping. The Range Officer is responsible for all firearms training and activities. The Academy is a division of the Department of Public Safety (DPS). DPS Accounting approves all procurement and expenditures through the Comptroller's Office.



The Training Academy's facilities consist of six buildings that are utilized for training, classrooms, housing, and office space for the administrative staff. Within those six buildings are thirty-five hotel rooms, six classrooms, two barracks and office space for instructors.

The Mississippi Law Enforcement Officers' Training Academy (MLEOTA) is committed to providing three (3) entry level Basic Law Enforcement classes per year. Each class is twelve weeks and begins with approximately seventy-five students. MLEOTA also conducts in-service classes and offers advanced classes for all state law enforcement agencies. The purpose of MLEOTA is to offer the most complete up to date law enforcement training possible and to deliver that training with professionalism, skill and effectiveness to provide protection to those within the State of Mississippi.

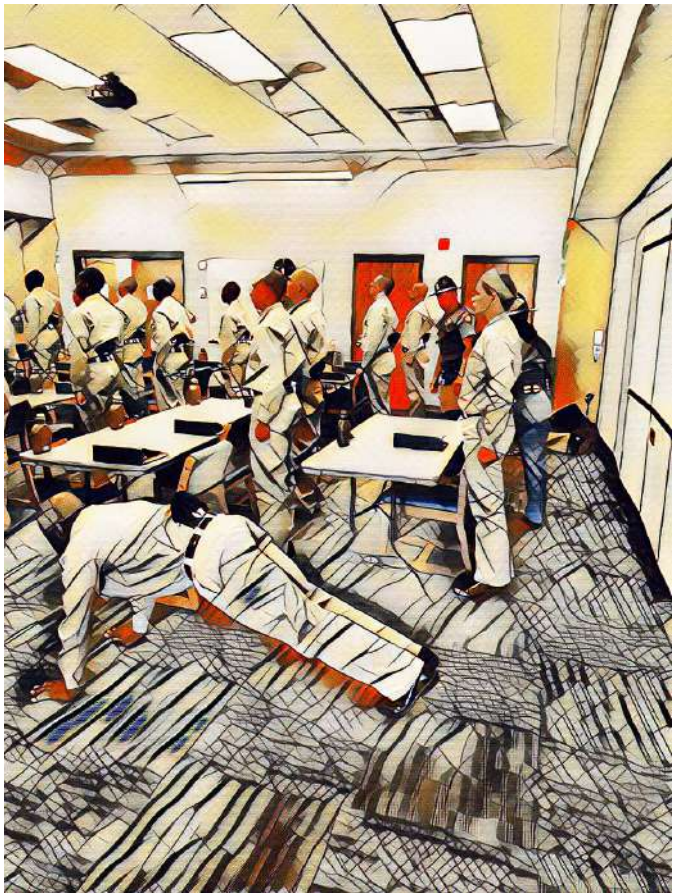
MLEOTA utilizes its funds in the most efficient and effective manner to promote a highly trained law enforcement community on the state and local level in a facility that is conducive to a learning environment to keep the general populace of Mississippi safe. Also, MLEOTA strives to ensure that the current law enforcement community on the state and local level receive advanced, updated training for the safety and well-being of the citizens of Mississippi.

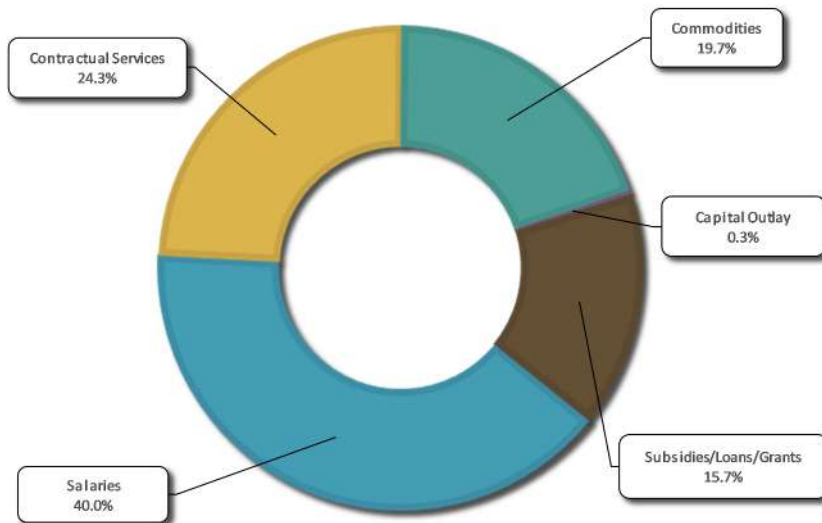

SUPPORT SERVICES

The Division of Support Services provides administrative and technical support to the other divisions of the Department of Public Safety. Support Services is composed of eight areas of responsibility which provide support to the agency.

COMPTROLLER'S OFFICE

The Comptroller's Office is responsible for accurately accumulating and recording all financial receipts and disbursements for the division of Mississippi Highway Safety Patrol, the division of Support Services, the Mississippi Law Enforcement Officers' Training Academy, the Mississippi Crime Laboratory, and the Mississippi State Medical Examiner's Office. Financial review, property accountability, supervision and advice are provided by the Comptroller's Office.



FIXED ASSET MANAGEMENT

The Fixed Asset Management Division is the custodian of the Department of Public Safety fixed asset records and is responsible for proper control, maintenance, use, and dissemination of those records. In addition, responsibility rests here for coordinating and conducting periodic physical inventories of the fixed assets and reporting the results of those physical inventories.

FORMS AND PRINTING

The Forms and Printing Branch is a service department that processes all incoming and outgoing mail at the Department of Public Safety headquarters complex. Personnel pick-up, sort and distribute incoming mail to the agency's different branches and bureaus. One example of this Branch's work is the distribution of approximately 360,060 driver's license renewal notices annually.

GRANTS ACCOUNTING OFFICE

The Grants Accounting Office is responsible for the accounting and purchasing functions of all federal grants distributed through the Department of Public Safety's Division of Public Safety Planning, as well as the accounting and purchasing functions for the Board of Law Enforcement Officer Standards and Training and the Board of Emergency Telecommunications.

MANAGEMENT INFORMATION SYSTEMS

The Management Information Systems Office is responsible for planning, operations, security, maintenance and oversight of the information technology infrastructure of the Mississippi Department of Public Safety. This infrastructure includes server farms, desktop environment, internal LAN management, external WAN management and law enforcement data communications to local, state, federal and international agencies.

PERSONNEL OFFICE

Personnel transactions involving over 1,100 positions of the Department of Public Safety are conducted by the central Personnel Office located at DPS Headquarters. Functions of the Personnel Office include advertising job openings and promotional opportunities within the organization in print and broadcast media, with college placement offices as well as with the State Personnel Board and the Mississippi Employment Security Commission.

PHYSICAL MAINTENANCE

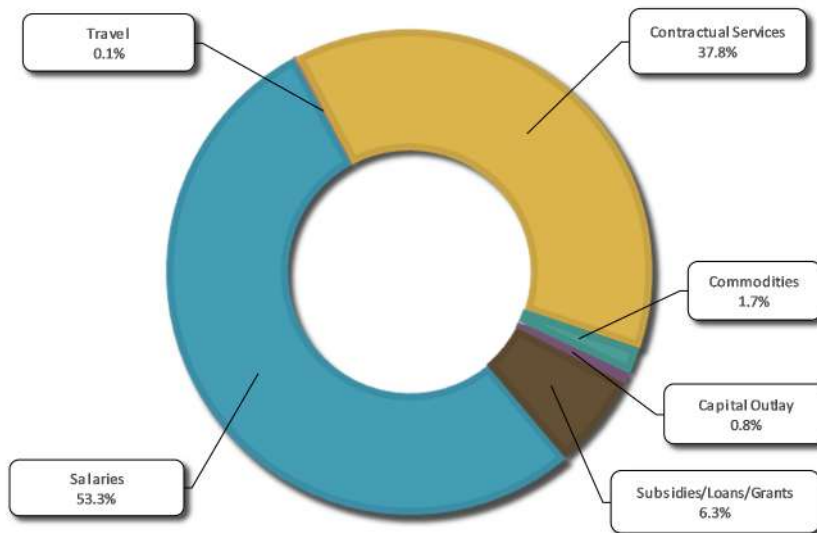
The employees of the Physical Maintenance Branch are responsible for maintaining the grounds, which includes servicing and maintaining the electrical, plumbing, and air-conditioning equipment. Also, the personnel perform all major repairs to the Highway Safety Patrol district substation and driver's license examining stations across the state.

PROCUREMENT OFFICE

The Procurement Office is responsible for the issuance of all purchase orders, maintenance of state and agency contract files, bid procedures and the assurance of compliance with state purchasing laws by the department and its components. Additionally, this office is responsible for procuring contractual services, commodities, and equipment for the Department of Public Safety.

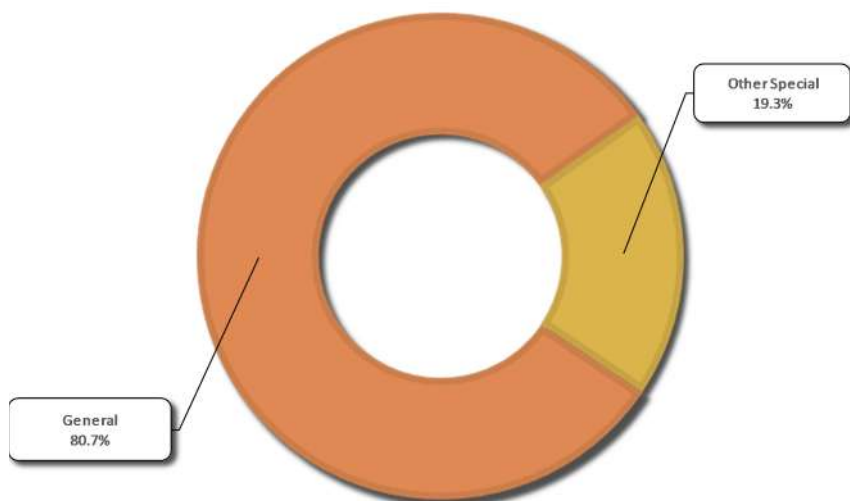

OFFICE OF PUBLIC SAFETY PLANNING

The Office of Public Safety Planning (PSP) provides training, funding, planning, prevention, and protection services through the work of its four divisions to ensure a safe and secure environment and enhanced quality of life for the citizens of the State of Mississippi. The Office of Public Safety Planning is made up of four components:

- Office of Justice Programs
- Office of Standards and Training
- Governor's Office of Highway Safety
- Mississippi Leadership Council on Aging

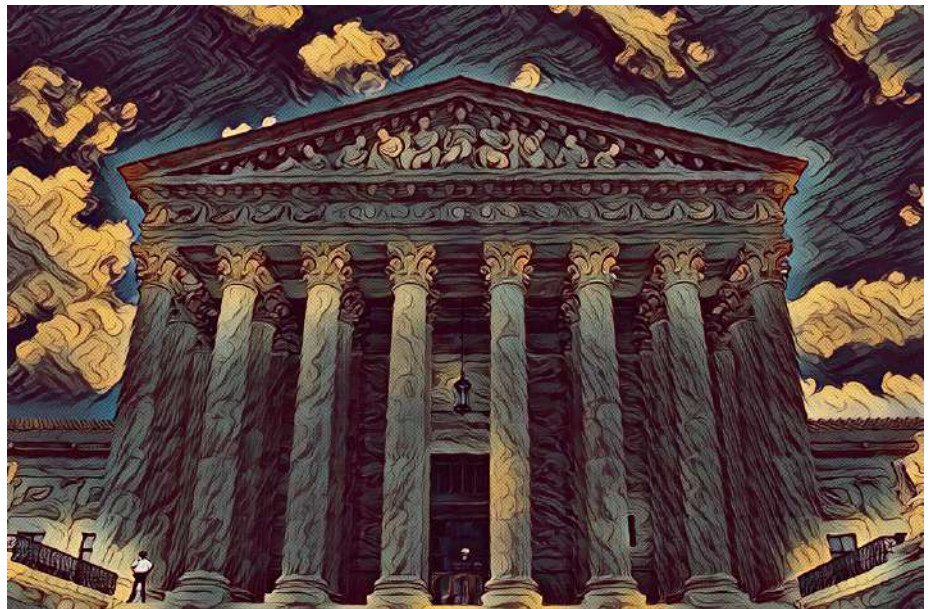
The Office of Standards and Training and the Mississippi Leadership Council on Aging are considered separate divisions for budgeting purposes.

OFFICE OF JUSTICE PROGRAMS

The Office of Justice Programs is responsible for increasing public safety through the development, implementation and evaluation of programs in the areas of criminal justice system improvements, juvenile justice delinquency prevention, residential substance abuse, prevention and intervention and services to violent crimes committed against women. This mission is accomplished through planning and developing state plans, providing funding to units of state and local government and public and private nonprofit agencies from approved plans, evaluation of programs, technical assistance and special initiatives.



Objectives:

- Administer OJP's grant awards process in a fair, accessible, and transparent fashion and, as good stewards of federal funds, manage the grant process in a manner that avoids waste, fraud, and abuse.
- Ensure integrity of, and respect for science including a focus on evidence-based, "smart on crime" approaches in criminal and juvenile justice.
- To strengthen partnerships with state, local and tribal stakeholders.

The Office of Justice Programs is comprised of the following divisions:

Edward Byrne Justice Assistance Grant Program (JAG)

This program provides the State, units of local government and tribal agencies critical funding assistance to prevent or reduce crime and violence through the provision of Local Law Enforcement Block Grants, funding for Drug Courts and Hot Spot Policing, forensic improvement grants, and residential substance abuse treatment programs for the Corrections community.

S.T.O.P. Violence Against Women Program (VAWA)

This program supports communities in their efforts to develop and strengthen effective law enforcement and prosecution strategies to combat violent crimes against women and to develop and strengthen victim services in cases involving violent crimes against women. Funding provision assists communities with victim services, prosecution, law enforcement, and the courts.

Sexual Assault Services Formula Program

This program directs grant dollars to states and territories to assist them in supporting rape crisis centers and other nonprofit, nongovernmental organizations or tribal programs that provide core services, direct intervention, and related assistance to victims of sexual assault. Funds provided through the SASP Formula Program are designed to supplement other funding sources directed at addressing sexual assault at the state and territorial level.

Juvenile Justice Programs

These programs of the Juvenile Justice unit are to achieve and maintain full compliance with the Juvenile Justice Delinquency and Prevention Act of 2002. The primary focus is to address deinstitutionalization of status offenders (DSO), separation of juveniles from adults in institutions (Separation), removal of juveniles from adult jails and lockups (Jail Removal), Disproportionate Minority Contact (DMC), alternatives to detention, and diversion.

Juvenile Facilities Monitoring Unit (JFMU)

This unit provides assistance to detention centers for compliance with State and Federal Laws. The JFMU gives leadership to assist in the direction of State juvenile detention facilities through the provision of technical assistance and action plans for efficient and effective facilities operation of centers thus, improving the future of juveniles detained in the system. JFMU is considered a separate division for budgeting purposes, but its expenditures are included with Public Safety Planning in this report.



MISSISSIPPI OFFICE OF HIGHWAY SAFETY

The mission of the Mississippi Office of Highway Safety is to encourage and assist state and local agencies, institutions and the private sector in establishing or expanding cooperative highway safety programs based on specifically identified traffic safety problems. The overall goal is to save lives by reducing traffic crashes which result in death, injury, and economic loss in the state.

In order to accomplish this goal, activities are carried out in the areas of alcohol/drug countermeasures and police traffic services that include speed, occupant protection, traffic records, roadway safety, and motorcycle safety. These efforts are funded primarily through the U.S. Department of Transportation and the National Highway Traffic Safety Administration (NHTSA).

The Mississippi Office of Highway Safety (MOHS) administers Mississippi's highway safety grant program in accordance with the provisions and all amendments of the Highway Safety Act of 1966. MOHS administers federally funded programs aimed at reducing traffic fatalities, traffic injuries and the associated economic losses from property damage crashes in the state.

The funds awarded to the MOHS include:

- ▶ General Traffic Safety (Section 402)
- ▶ Open Container Funds (Section 154)
- ▶ Occupant Protection Funds (Section 405b)
- ▶ Traffic Records Funds (Section 405c)
- ▶ Impaired Driving Funds (Section 405d)

These funds support Mississippi's critical Highway Safety initiatives, which include:

- ▶ Impaired Driving programs,
- ▶ Occupant Protection programs,
- ▶ Police Traffic Services,
- ▶ Public Information & Education,
- ▶ Traffic Records,
- ▶ Driver's Education,
- ▶ Motorcycle programs, and
- ▶ Youth programs.



Mississippi has a proven and successful record of accomplishment in increasing the public's knowledge, perception, and understanding of traffic safety issues. The fatality rate has declined from a high of 4.39 VMT in 1981 to 1.54 VMT in 2014.

However, Mississippi still has more to do to drive down fatalities and injuries. Unfortunately, traffic fatalities increased from 677 in 2015 to 690 in 2016. Mississippi saw an increase in traffic injuries from 27,955 in 2015 to 29,373 in 2016 in Type A, B and C injury crashes.

Although the traffic safety data shows increases in many of the MOHS priority programs, the MOHS was successful in achieving the following achievements:

- ▶ Alcohol-Impaired Driving Fatalities decreased 27.7% (from 177 in 2015 to 128 in 2016) - which was the largest decrease in alcohol-impaired driving fatalities in the United States
- ▶ Percentage of unbelted fatalities decreased from 55.3% in 2015 to 53.83% in 2016
- ▶ Seatbelt usage in Mississippi increased from 77.9% in 2016 to 78.8% in 2017
- ▶ Total number of teen fatalities (16-20) decreased 24% (from 78 in 2015 to 59 in 2016)
- ▶ Total speed fatalities decreased 16% - from 96 in 2015 to 81 in 2016

MOHS remains committed to serving Mississippi through best practices, data-driven approaches and evidenced-based programs to continue the successes of this program. Our support of law enforcement, non-profit, local, and state partners will continue to grow while meeting joint goals of reducing fatalities, decreasing injuries and crashes on the Mississippi roadways.

FY2017 Mississippi Legislation

During the 2017 Mississippi legislative session, there were forty-one (41) highway safety-related bills that were presented to legislative committees for consideration. These included:

- ▶ Twenty-one bills related to DUI/Impaired driving
- ▶ One bill related to Distracted Driving
- ▶ Six bills related to speed on our roadways
- ▶ One Graduated Driving License bill
- ▶ One bill related to texting while driving
- ▶ Seven bills related to seatbelt or child restraint use
- ▶ One bicycle bill
- ▶ Three motorcycle bills

Out of these, one highway safety-related bill was passed through both the House of Representatives and Senate and signed by the Governor. Harlie's Law (Senate Bill 2724) requires all passengers of a motor vehicle to wear seat belts except those required to use a child restraint system.

2017 Core Performance Measures

MOHS works diligently with all agencies, creating strategic plans and hosting strategic planning meetings in an effort to reach core outcome and behavior measures for FY18 and FY19. The reduction of law enforcement within the Mississippi Highway Patrol and local agencies is one of the challenges that the overall program faced in FY17. Some of the available performance targets are presented here (some measures are not available at the time of printing, but should be found in the separate MOHS Annual Report when issued).

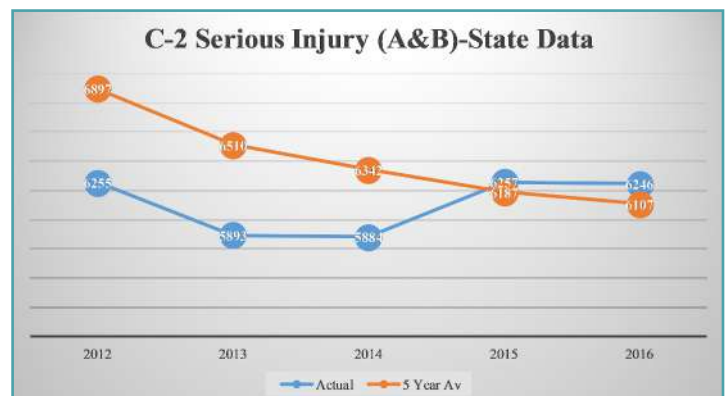


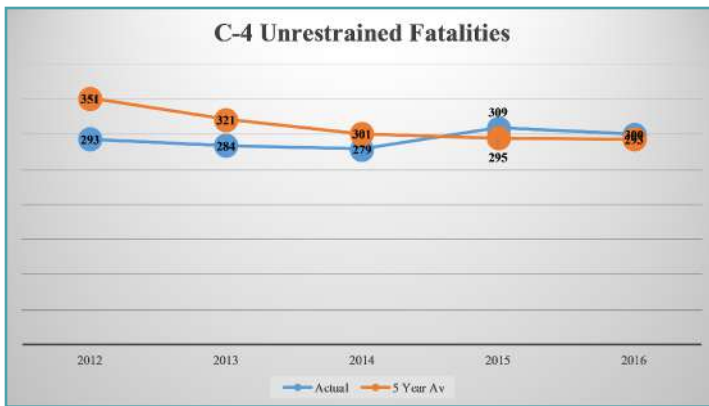
Core Outcome Measure: Number of Traffic Fatalities

For this reporting period, fatalities increased from 677 in 2015 calendar year to 690 in 2016. Regrettably, the fatalities are higher than the target of 615. However, MOHS continues to work toward reducing overall fatalities across the State.

Core Outcome Measure: Serious Injury

While the number of serious injuries appears to have plateaued, the five-year moving average declined year-over-year.



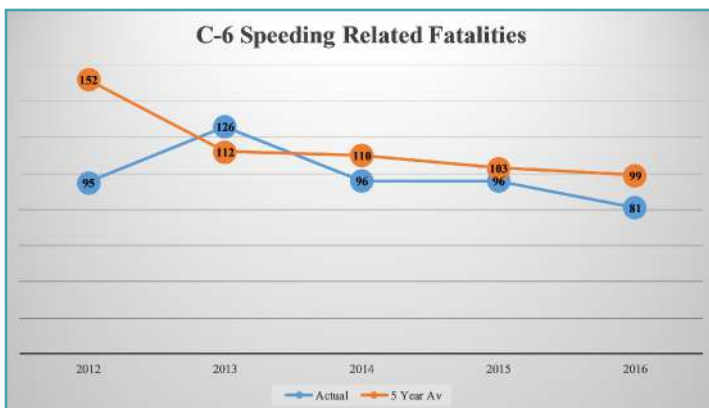
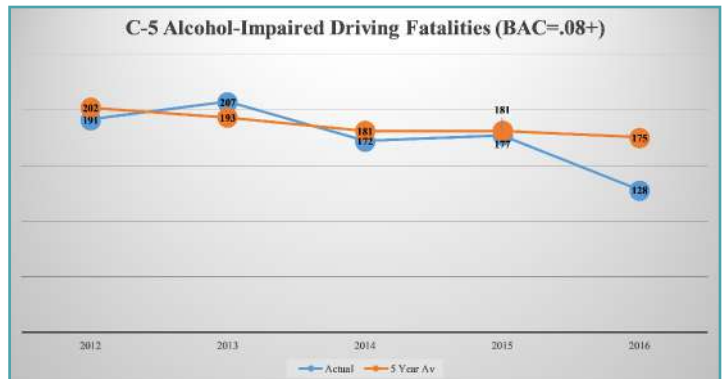


Core Outcome Measure: Unrestrained Passenger Fatalities

The 2016 FARS data shows a decrease in unrestrained fatalities from 309 in 2015 to 300 in 2016. The MOHS met its five-year average goal of 293.

Core Outcome Measure: Alcohol-Impaired Driving

The 2016 FARS data shows a drastic decrease in impaired driving fatalities from 177 in 2015 to 128 in 2016. The five-year average goal of 180 by the end of 2017 was not only met but exceeded.

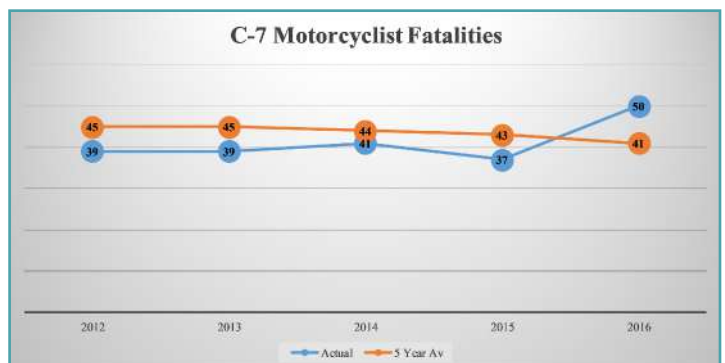


Core Outcome Measure: Speeding-Related Fatalities

The 2016 FARS data shows that the number of speed related fatalities decreased from 96 in 2015 to 81 in 2016. The MOHS met and exceeded the five-year average goal of 106 by the end of 2017.

Core Outcome Measure: Motorcycle Fatalities

While the 2016 FARS data shows a significant increase in motorcycle fatalities from 37 in 2015 to 50 in 2016, the five-year average goal of 42 was exceeded.

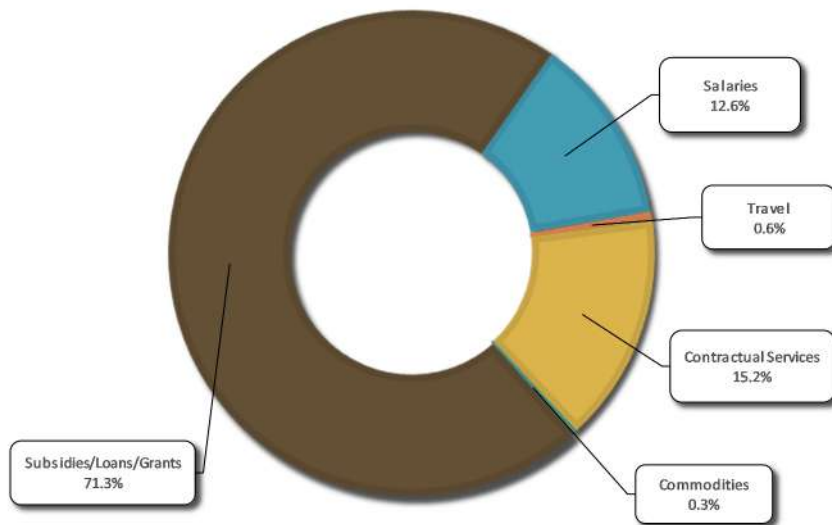

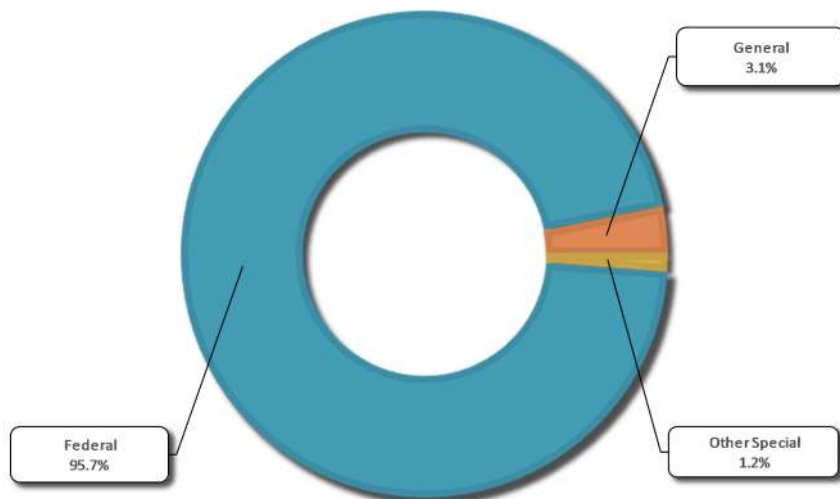

BOARD ON LAW ENFORCEMENT OFFICER STANDARDS AND TRAINING

The mission of the Board on Law Enforcement Officer Standards and Training (BLEOST) is to establish and enforce standards to ensure that the people of Mississippi are served by highly trained and ethical law enforcement personnel. The Legislature finds that the administration of criminal justice is of statewide concern, and that the activities of law enforcement officers are important to the health, safety and welfare of the people of this state and is of such nature as to require selection, education and training of a professional nature upon entrance and during the careers of law enforcement officers.

The purpose of the Board on Law Enforcement Officer Standards and Training is to ensure that law enforcement officers are selected according to high standards and receive the most current training statewide. The Board establishes standards for entrance into the profession of law enforcement and maintains files on all officers to ensure continuous compliance with all standards and training. The Board develops and administers the basic curriculum for full-time and part-time law enforcement officers; approves, certifies, and monitors instructors, full-time academies, and part-time academies; and monitors compliance with the requirements of the Law Enforcement Officers' Training Program.

The certification of law enforcement officers is the core program of the Board. The Board's staff examines the application of all individuals hired as law enforcement officers. If those individuals meet the background standards set by the Board, and complete the required training, the staff issues a professional certification which gives that officer the powers of a peace officer. The Board has the authority to cancel the certification of officers that do not maintain those standards. The staff issues reimbursement of at least 50% of the cost of training to the county, municipal or state law enforcement entity. The staff monitors the continuing education of officers, chiefs, and sheriffs as required by State law.

The Board established the Mississippi Law Enforcement Accreditation Commission that approves professional standards for law enforcement agencies. The Commission develops and administers the program in order to recognize professional excellence in the law enforcement community. The Board provides model sample policies and assists agencies in developing policy.

The Board has continued to work closely with the law enforcement community, local government leaders and educators to ensure uninterrupted progress in the law enforcement profession. Careful selection and adequate training of law enforcement officers will result in the greatest potential for successful performance of complex law enforcement duties.

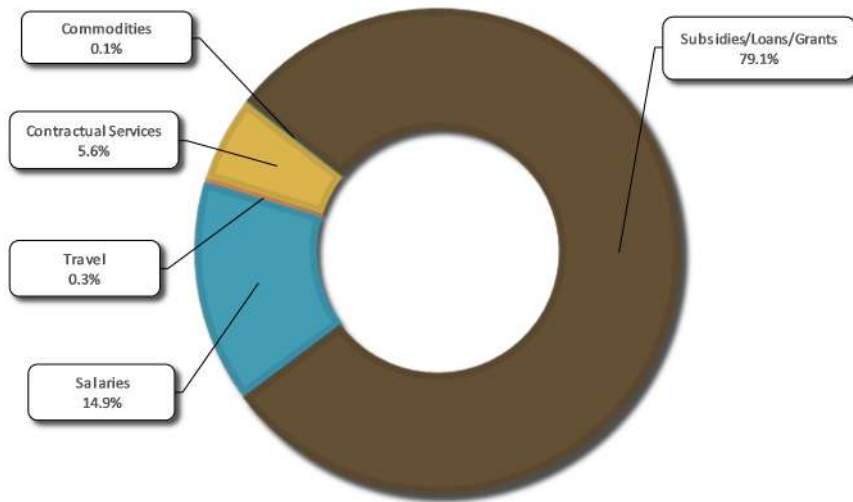

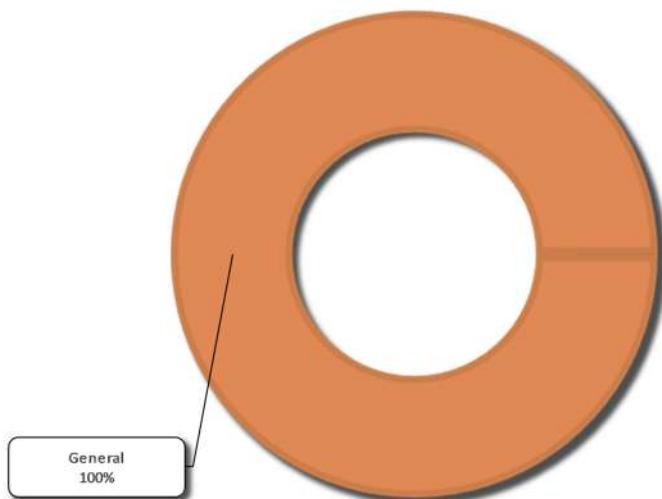
BOARD ON LAW ENFORCEMENT OFFICER STANDARDS AND TRAINING FINANCIAL SUMMARY

BOARD ON JAIL OFFICER STANDARDS AND TRAINING

The mission of the Board on Jail Officer Standards and Training (JOST) is to establish and enforce standards to ensure that the people of Mississippi are served by highly trained and ethical jail and youth detention personnel. The Legislature has found that the administration of jails and youth detention facilities is of statewide concern and that the activities of jail officers are important to the health, safety and welfare of the people of this state and is of such nature as to require education and training of a professional nature for jail officers.

The purpose of the Board is to ensure that jail officers are selected according to high standards. Once selected, the Board intends that jail officers have the best preparation feasible to enable them to carry out their duties in a manner that protects the health, safety and welfare of the citizens of this state.

The Board on Jail Officer Standards and Training approves and administers the curriculum and approves the training delivery system for all jail officers (county, municipal and youth detention); maintains files on all jail officers to ensure continuous compliance with all standards and training; approves instructors; and monitors compliance with the requirements of the Jail Officer Training Program.

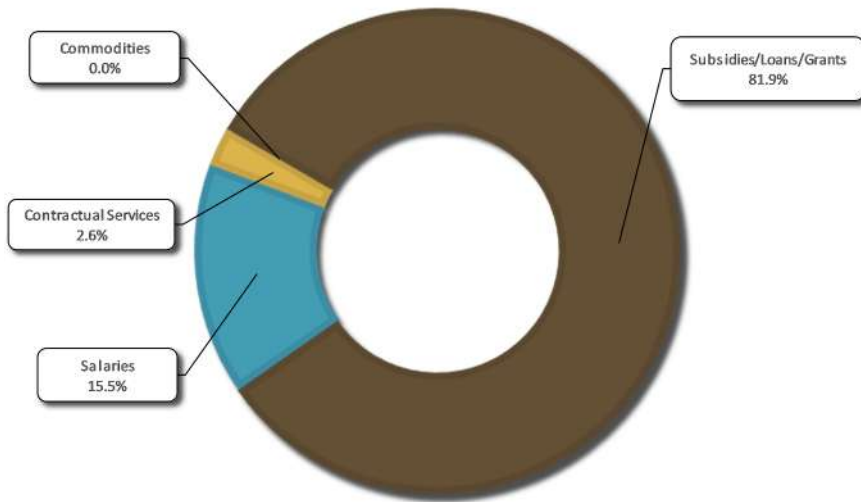
The certification of Jail and Youth Detention Officers is the core program of the Board. The Board's staff examine the applications of all individuals hired as jail and youth detention officers. If those individuals meet the background standards set by the Board and complete the required training, the staff issues a professional certification which gives them the authority to work as jail and youth detention officers. The Board has the authority to cancel the certification of officers that do not maintain those standards. The staff issues reimbursement of 100% of the cost of training to the county or municipality.

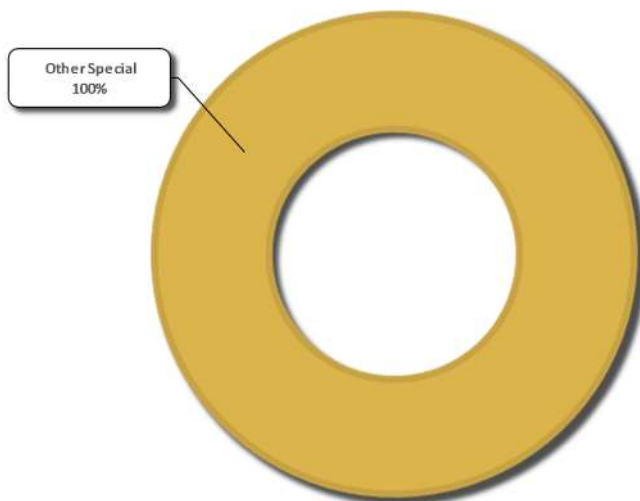

BOARD OF EMERGENCY TELECOMMUNICATIONS STANDARDS AND TRAINING

The mission of the Board of Emergency Telecommunications Standards and Training is to establish and enforce standards to ensure that the people of Mississippi are served by highly trained and ethical emergency telecommunications personnel. It is in the best interest of the public to reduce the time required for a citizen to request and receive emergency aid and to raise the level of competence of local public safety and 911 telecommunications.

The purpose of the Board is to ensure that emergency telecommunications have the best preparation available to enable them to carry out their duties in a manner that protects the health, safety and welfare of the citizens of this state. Thus, the Board of Emergency Telecommunications Standards and Training establishes standards for entrance into the profession of public safety telecommunications; approves and administers the curriculum for basic and re-certification training for all emergency telecommunications; maintains files on all telecommunications to ensure continuous

compliance with all standards and training; approves, certifies and monitors instructors; and monitors compliance with the requirements of the Emergency Telecommunications Training Program.

The certification of emergency public safety telecommunications is the core program of the Board. Certification ensures that the people of Mississippi are served by highly trained and ethical telecommunications. The Board staff examines the applications of all individuals hired as public safety telecommunications. If those individuals meet the background standards set by the Board and complete the required training, the staff issues a professional certification which gives them the authority to receive and dispatch calls for assistance from the public. The Board will reimburse 100% of the cost of training to the corresponding county, municipal or state entity. The Board has the authority to cancel the certification of any telecommunications that do not maintain those standards.

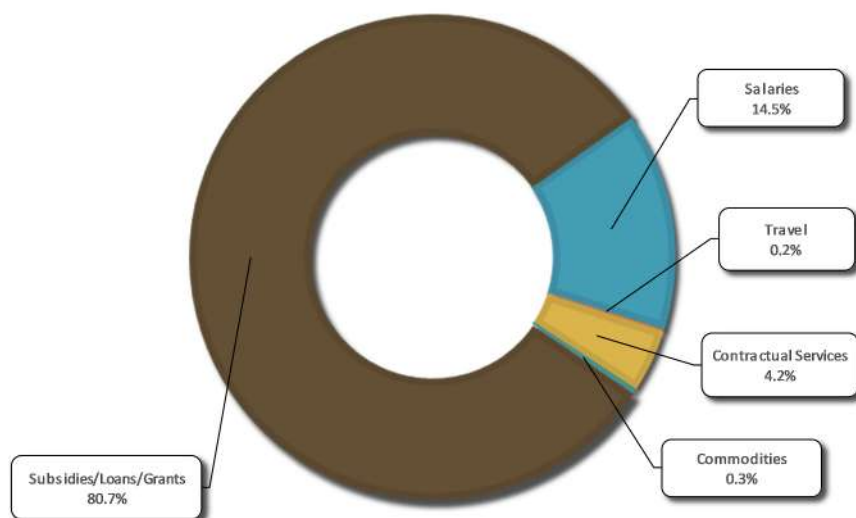

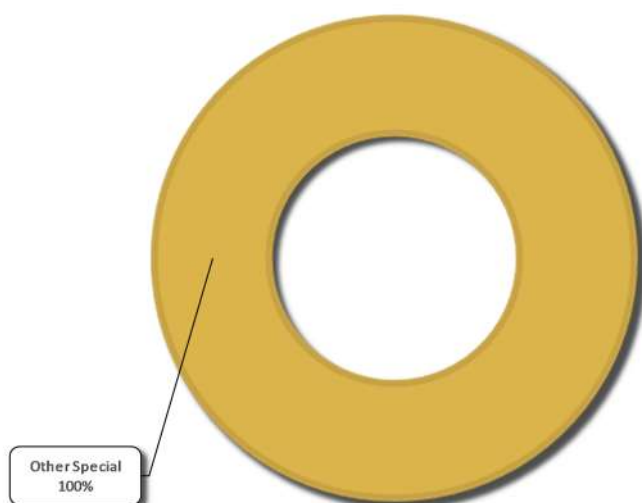

MISSISSIPPI LEADERSHIP COUNCIL ON AGING

The mission of the Mississippi Leadership Council on Aging (MLCOA) is to promote a coordinated effort among law enforcement, social services and local communities to reduce crimes against senior citizens. The Council supports media and non-media strategies aimed at increasing both public understanding of the problem and senior citizens' skills in preventing crime against themselves and their property.

MLCOA strives to address the problem of crime against senior citizens in a systematic and effective manner by promoting and expanding collaborative crime prevention programs such as the TRIAD mode which assists law enforcement agencies and senior citizens in implementing specific strategies for crime prevention, victim assistance, citizen involvement and public education. The MLCOA has two full-time employees located in the Office of Public Safety Planning.

The MLCOA Board consists of:

- I. One representative of the Department of Public Safety;
- II. Two representatives of the Mississippi Sheriff's Association;
- III. Two representatives of the Mississippi Chiefs of Police Association;
- IV. One representative of the Mississippi Department of Human Services, Division of Aging and Adult Services;
- V. Two representatives of the American Association of Retired Persons;
- VI. Two representatives of community volunteer Councils on Aging;
- VII. One representative from the Office of the Attorney General's Crime Prevention Unit ; and
- VIII. Two representatives from the aging advocate network.

MLCOA goals are to administer the TRIAD concept and enhance the delivery of law enforcement services to mature people. TRIAD is a concept of partnership. It is not an acronym; rather it represents a group of three: law enforcement, seniors or senior organizations, and community. This results in an agreement between law

enforcement agencies in a county (sheriff's office, police department, etc.) and older or retired persons in the community to work together in a partnership to address crime issues which affect older citizens.

There are 52 TRIAD programs in operation in Mississippi that are being funded through grants from MLCOA. This represents 60% toward fulfilling the goal of having a TRIAD program in all 82 counties. In order to ensure older Mississippians are protected and are safe in their own homes, MLCOA will work to continue establishing new TRIADs.

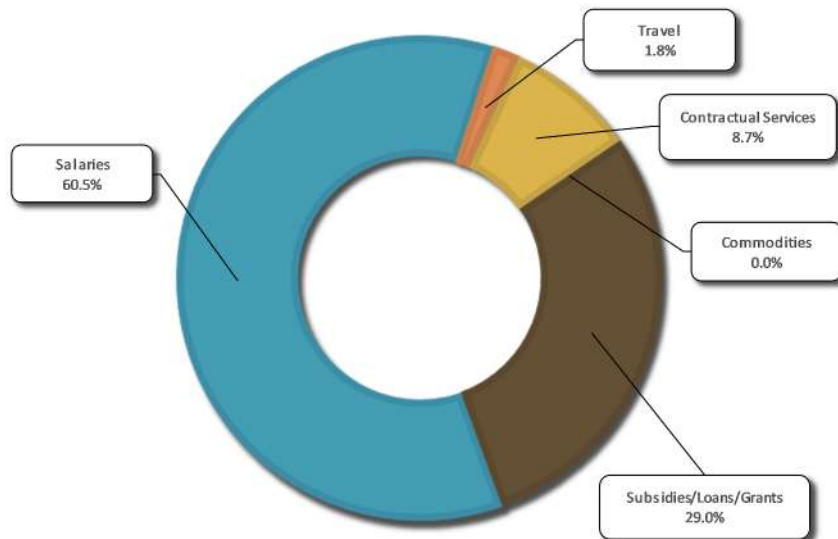
The MLCOA will continue to support the proper utilization of state grant funds to reduce crime against the elderly by:

- ▶ Educating seniors of scams and frauds in efforts to prevent them from becoming victimized.
- ▶ Developing, implementing and enforcing professional standards and creating opportunities for law enforcement communities and TRIAD programs to grow.
- ▶ Ensuring that TRIAD complies with legislation on how programs spend their funds.
- ▶ Providing efficient and effective indirect administration to every law enforcement agency and TRIAD programs at the greatest value to the State of Mississippi.



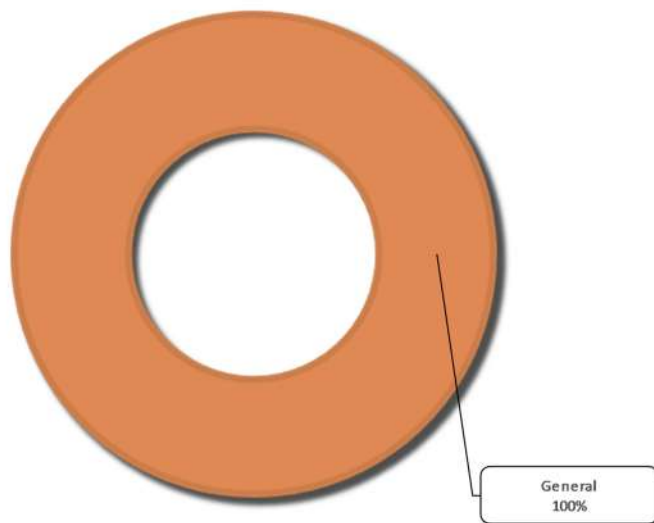
MISSISSIPPI LEADERSHIP COUNCIL ON AGING FINANCIAL SUMMARY
